This bid is for construction of reinforced concrete footers, walls and floor for the WVDOH Salt Shed located at the WVDOH Tucker County Substation on WV 32 (.6) miles east of Thomas, WV . (See attached map) The footer, walls and floor shall be constructed in accordance with the plans. The building will be 72' wide by 140'3" long. The footers will be 2' thick by 5 wide. The walls shall be 18" thick by 12' high. The floor shall be 9" thick. Finish for concrete walls shall be plain, rubbed finish or shall have a simulated brick pattern.

- 1. Form panels and all form hardware, including all necessary ties and bracing
- 2. All labor to set and brace forms
- 3. All labor to install and the reinforcing steel and wire for footer, walls and floor






