## GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services.
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
12. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.

## 1. BIDDING INSTRUCTIONS

The purpose of this contract is to provide brine dispensing system to the West Virginia Division of Highways per the attached description or specifications.

Any qualifications of bids or modification of the specifications, design, or conditions governing the bids may be cause to reject bids.

## 2. DESCRIPTION

The successful bidder shall provide all labor and materials necessary to install Calcote Pedestal Model CP-50-RC, or equal, liquid deicer dispensing system.

The unit shall be used to pre-wet solid deicing materials by the truckload or front end loader bucket and shall be capable of loading and unloading mounted liquid storage tanks.

The overhead spray function shall be controlled either manually by buttons on the panel cover or remote control transmitter.

The system shall be free standing and will not require a mounting post or a fixed base for mounting.

All fabricated steel components including base, main body, and spray arm of the unit shall be hot dip galvanized, meeting ASTM specification A123, for corrosion protection.

Dimensions: the pedestal height shall be 10'4", spray arm height (horizontal position) 9'4", spray head distance from pivot 8'6", pedestal base 3'X3'X3.5".

The vertical movement of the spray arm shall be accomplished manually by a hand winch rated at 800 pounds.

The spray head shall be made of 1.5" sch 80 PVC with 4 – 1" brass spray nozzles spaced at 15" intervals.

The unit shall have a stainless steel centrifugal pump with a 2" inlet, a 1.5" outlet, and a rated flow of 60 gpm.

The pump shall be close coupled to a 2 hp, 3450 rpm, TEFC, 208-230 volt single phase motor.

The pump motor assembly shall be housed for protection in a rotationally molded, UV stabilized polyethylene enclosure.

Electrical wiring from the pump motor to the electrical box shall be contained in Liquitight flexible conduit with Liquitight connectors at both ends.

The assembly shall be mounted to the pedestal base. All electrical controls shall be mounted in a fiberglass NEMA 4X weathertight enclosure with hinged cover for easy access and lockable latch.

Hinges and latches shall be stainless steel.

The cover shall have a power disconnect switch, run/stop buttons for manual operation in hand position, and hand position for automatic operation with remote transmitter.

The interior of the box shall contain a magnetic motor starter with thermal overload reset, terminal strip, relays, timers, transformers, remote control circuit board, and a power disconnect switch.

The pump control timer shall have multiple settings which enables calibrations of various application rates.

The electrical control box shall be mounted to the main body of the pedestal.

Electrical service (220 volt, 20 amp single phase) connection to the electrical control box will be supplied by the DOH.

The successful bidder will advise the DOH of materials that will be needed to establish hook up well in advance of installation and shall provide technical assistance to the DOH for electrical hook up and calibration when the system is installed.

All plumbing components shall be made of corrosive resistant materials.

Manifold style fittings shall be used for connections to facilitate repair and maintenance.

The truck load and unload hoses are to be 1" chloride resistant rubber, 25 feet in length, with 1" poly valves and quick couple connectors.

Two poly three-way valves shall be included to allow for directional flow to the overhead spray system or the truck load/unload hoses.

All hose clamps used are to be stainless steel.

A 2" stainless steel tank shutoff valve shall be installed at the tank outlet and up to 30 feet of 2" flexible PVC hose with fittings shall be installed from the tank to the pump.

An electric ball valve shall be installed to prevent siphoning through the system.

The valve will automatically open when the pump system is activated and will close when the pump shuts off.

### **3. CONTRACT AWARD**

Contract will be awarded to the qualified vendor who submits the lowest bid.

In the event a vendor fails to conform to the requirements set out in this contract document, the State Contract Order or the governing specifications, the Contract may be cancelled and awarded to the next lowest bidder.
