



We will conduct the random testing program and provide written reports in an efficient, timely manner. SCOPE OF WORK

1. Random Selection Methodology: i3screen will develop a method of random selection in compliance with the Department of Transportation Rule, 49 CFR Part 40.

2. Mobile, On-Site Urine Collections: i3screen will provide mobile, on-site testing of urine in compliance with 49 CFR Part 40, including necessary collection and identification supplies and transportation costs from the collection site to a SAMHSA certified laboratory. i3screen will utilize the split sample method of collection, handling, and storage. Unless specifically requested by the West Virginia Department of Transportation (WVDOT), United States Department of Transportation (U.S. DOT) collections protocols will be followed at all times.

i3screen will provide a confirmatory test on all presumptive positive drug screens using gas chromatography/mass spectrometry (GC/MS). i3screen will report drug tests results to the WVDOT no later than 4:00 PM Eastern Time on the third business day following the date of a test. If not reported by that time, i3screen will not charge the WVDOT for the test, and will not reschedule a test for the purpose of meeting this required timeframe.

3. Mobile, On-Site Alcohol Testing: i3screen will provide for mobile, on-site alcohol testing to be conducted using equipment approved by the U.S. DOT and found on their Conforming Products List. Unless specifically requested otherwise by the WVDOT, i3screen will follow U.S. DOT collection protocols found in 49 CFR Part 40. i3screen will provide for a confirmatory alcohol test on all breath concentrations in excess of 0.02.

4. Supervisor Presence for Random Testing: i3screen will ensure that no collector begins random testing without the presence of the organization's site supervisor who handles the drug and alcohol testing program for their specific organization.

5. Specimen Adulteration Assays: i3screen will not charge the WVDOT for specimen adulteration assays.

6. Rejected Specimens: i3screen will not charge the WVDOT for handling of rejected specimens or those otherwise unfit for testing.

7. Medical Review Officer: i3screen has included the cost of a qualified, full-time Medical Review Officer (MRO) in the per test cost submitted in this quotation. i3screen has four full-time, dedicated MROs on staff, including Chief MRO David R. 8. Hours of Testing: i3screen will provide mobile testing and testing services from 7:00 a.m. until 5:00 p.m. Monday – Friday. i3screen will provide after hours services (including Saturday and Sunday collections, if necessary) when required in emergency situations.

9. Test Scheduling Timeframe: i3screen will promptly schedule all pre-employment and follow-up testing. All tests will be completed within two days. i3screen understands that clinic scheduling will be necessary.

10. Blood Specimens: i3screen will provide for the collection of blood specimens, if necessary.

11. Blind Samples: i3screen will provide for the submission of blind samples as required by federal regulations.

12. Web-Based Reporting Module: i3screen will provide a customized, secure, web-based result reporting and random pool maintenance module at no cost to the WVDOT for tracking, management, and record maintenance of the WVDOT program. A notice listing all currently certified Laboratories and Instrumented Initial Testing Facilities (IITF) is published in the *Federal Register* during the first week of each month. If any Laboratory/IITF's certification is suspended or revoked, the Laboratory/IITF will be omitted from subsequent lists until such time as it is restored to full certification under the Mandatory Guidelines.

The "Mandatory Guidelines for Federal Workplace Drug Testing Programs", as amended in the revisions listed above, requires (or sets) strict standards that Laboratories and

Instrumented Initial Testing Facilities (IITF) must meet in order to conduct drug and specimen validity tests on urine specimens for Federal agencies.

To become certified, an applicant Laboratory/IITF must undergo three rounds of performance testing plus an on-site inspection. To maintain that certification, a Laboratory/IITF must participate in a quarterly performance testing program plus undergo periodic, on-site inspections.

Laboratories and Instrumented Initial Testing Facilities (IITF) in the applicant stage of certification are not to be considered as meeting the minimum requirements described in the HHS Mandatory Guidelines. A Laboratory/IITF must have its letter of certification from HHS/SAMHSA (formerly: HHS/NIDA) which attests that it has met minimum standards.
