To Whom It May Concern,

My name is Eric Miller and I am an Account Executive for Fire Fighter Sales and Service Co. I am submitting a bid for the services at the Department of Corrections Facilities. I visited (5) of the largest facilities so that I have a pretty good idea of what type of equipment there is and how things are accomplished.

I submitted pricing a little differently, I have an excel spreadsheet that covers the Fire Alarm Inspections, Sprinkler Inspections, Fire Pump Testing, and Fire Hydrants. This is flat rate pricing to cover these areas. I am not quoting the pricing on the SCBA equipment.

The Extinguisher and Kitchen Suppression Inspections are itemized pricing based on the number of extinguishers and what kind of service needs done on them. It is hard to put a flat rate on extinguisher pricing because every 6 years and 12 years they are due for test so not knowing the age of the extinguisher and the last test that was done, you can't really give it a "flat rate". So what I did was supply a number that includes the annual inspection with a service charge built in to include travel time and overnight stays. The pricing does not include any 6-year or hydrotest pricing because, not know the age and the last test dates of the extinguishers out there it is very difficult to supply pricing.
