## GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services.
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.



**PURCHASING AFFIDAVIT**

**West Virginia Code §5A-3-10a states:** No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate.

Our company is an award-winning, twenty-nine year old cultural resources management firm with a national practice and specialized expertise across the spectrum of historic preservation disciplines. We have extensive experience in executing large-scale reconnaissance level architectural history surveys and have pioneered innovative and cost-effective methodologies for data collection and analysis tailored to our client's objectives and reporting requirements. Our team brings to this project a demonstrated knowledge of historic preservation laws, regulations, standards, and guidelines; a full-time professional staff of 120, including 14 historians and architectural historians who exceed the Secretary of the Interior's professional qualification standards; and a record of successful past performance. Goodwin & Associates, Inc. will distribute summary minutes for review and approval to meeting participants within five working days of the meeting. Goodwin & Associates, Inc. formally will apprise the SHPO of progress on the project through monthly progress reports submitted electronically to the SHPO point of contact.

### **Item #1: Historic Research and Historic Contexts**

Succinct historic contexts for each of the four counties will be developed through a progressive program of archival research, analysis, and document preparation. Each historic context will provide an overview history organized by major periods of development, identify important



historical themes and geographic areas, and define associated property types. All work will be undertaken in close coordination with SHPO staff.

Archival research will be conducted using primary and secondary sources. The collections of state and local libraries, archives, and historical societies will be reviewed. Specific archives utilized in this effort will include the West Virginia State Archives, the West Virginia Collection at West Virginia University, and the Library of Congress.

Comprehensive historical overviews organized by chronological periods of development will be developed for each county. These historical overviews will be used to identify important themes and subthemes appropriate for directed research. Overviews and theme studies then will be analyzed to identify the range of property types associated with each historic context. This data will be used to develop the range of potential property types associated with each historic context. Property types will be defined through descriptions, character defining features, patterns of evolution over time, and specific issues related to the integrity of anticipated resources.

Draft historic contexts will be submitted for review by the staff of the SHPO. Each county history will be presented in an individual report with footnotes and bibliography; reference citations will be formatted in accordance with *Chicago Manual of Style*. All comments received on the draft submissions will be addressed in the final documents. One bound copy and one electronic copy formatted in Microsoft Word on CD will be submitted for both draft and final products, as required under the Request for Quotation.

## **Item #2: Field Survey**

In consultation with the SHPO, Goodwin & Associates, Inc. will develop a GIS-based survey form for data collection in the field based on the West Virginia Historic Property Inventory (HPI) form. This form will be designed to operate on a Trimble XT/XM hand-held computer with Global Positioning System (GPS) that has sub-meter accuracy for use in the field. Survey data will be exported into Microsoft Access to facilitate production of hard copies and PDFs of each form.

Goodwin & Associates, Inc. staff will undertake the reconnaissance-level field survey of 750 properties within Calhoun, Clay, Wirt, and Roane counties following consultation with the SHPO regarding the level of effort within each county. Each survey team will be briefed fully on the county historic context and requirements of the project. Each survey team will be directed by personnel who meets or exceed the Secretary of Interior's *Professional Qualification Standards* (48 FR 44716) for history or architectural history:

The survey will be conducted by multiple teams using handheld Trimble XT/XM computer/GPS units to record each building and structure that are at least fifty years old and retain architectural integrity. A minimum of two photographs, including a three-quarter view of the main elevation, will be executed to document the current appearance of the resources. All images will meet the National Park Service's standards for electronic images. Each photograph will be at a minimum 1600 x 1200 pixels at a resolution of 300 pixels per inch. All survey will be conducted from the public right-of-way, and GIS points will be projected to the front of the building, structure, or object using a distance meter.



Field data will be reviewed on a daily basis for substantive and technical accuracy. HPI forms will be submitted with imbedded photographs in paper and electronic copies, as specified in the Request for Quotation.

### **Item #3: Mapping**

Following the completion of the field survey, USGS topographic maps will be electronically generated for each surveyed property. Maps will be labeled with the name of the county, quadrangle name, and resource number. Site locations will be digitized as an ESRI shape file using the site number as the identifying attribute. Final survey data will be provided to the SHPO in both paper copies and electronic formats.

### **Item #4: Recommendations**

Following the completion of the reconnaissance survey effort, survey data will be analyzed for each county applying the National Register criteria for evaluation (36 CFR 60 [a-d]) within the appropriate historic context developed under Item #1. Electronic field data will be managed using Excel and Access programs to facilitate comparative analysis of the resources by such qualities as date range, thematic association, building type, architectural style, and materials.

Recommendations will be developed for properties that possess the qualities of significance and integrity necessary for listing on the National Register of Historic Places both individually and collectively as part of potential historic districts. In addition, recommendations will be made regarding the potential for multiple property listings, such as one room schoolhouses, that may be identified in the course of the survey. All recommendations will be justified fully and accompanied by appropriate documentation.

A summary technical report with recommendations will be prepared for submission to the SHPO. Draft recommendations will be submitted to the SHPO for review in accordance with the scope of work; all comments will be addressed in the final document.

### **Item #5: Final Survey Report**

The final survey reports will be prepared for each county investigated. These reports will include the historic context for the county, survey methodology, identification and description of property types, USGS maps for each property and county, survey data presented in tabular form, and the National Register recommendations. Draft reports will be submitted to the SHPO for review. All comments received from the SHPO will be addressed in the final report. The final reports will be submitted as PDF files and hard copies.



## Key Staff

Key staff for this project was selected for their past experience in executing large-scale reconnaissance-level architectural history surveys and working knowledge of West Virginia history and architectural history. Full resumes for key staff are attached. The project team will comprise qualified historians, architectural historians, GIS specialists, and support staff to execute the project in accordance with SHPO priorities and schedules.

***Architectural Reconnaissance Survey, Blue Creek Wind Energy Project, Paulding and Van Wert Counties, Ohio (2009)***
