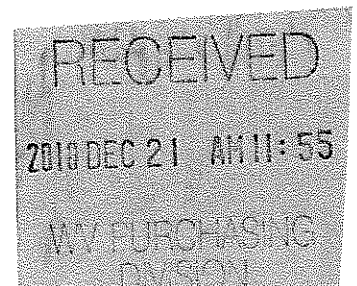
Please note that the manufacturer has discontinued Item 17. The 5.11 4-in-1 jacket (Item 19) has been substituted for the discontinued item.



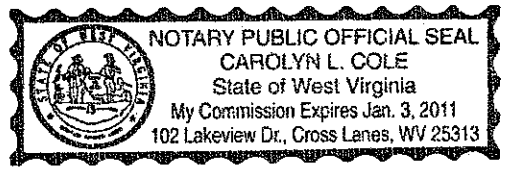
