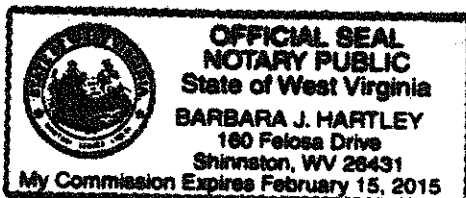

Addendum 1 and specifications

Q 1 The 1/8 difference in length is not a ballistics issue or a holster fit issue. (See Q 3)
Glock's polymer frames are stronger than steel and much more durable. The polymer frame flexes and absorbs the recoil, preventing cracking of the frame and stress on other parts. The slide and barrel use a hi-tech tenifer surface refinement, corrosion proof and a degree of hardness of 64 HRC, close to that of a diamond.

Q 2 The magazines supplied with the Glock 21 SF pistol are steel lined polymer with a capacity of 13 rounds, nearly double that of the S&W 4566, 8 round magazines, This is a large tactical advantage.


Q 3 At the cost that we are bidding the Glock 21 SF pistols, the State Police could purchase all new holsters and magazine pouches, and the taxpayers of the state of West Virginia would still be over one hundred thousand dollars to the good.

The Streamlight TLR 1 weapons light is designed to fit Glock and S&W pistols as well as several other makes.

Q 4 Glock offers a lifetime warranty on weapons supplied to law enforcement agencies. It is based on a 40,000 round life. Most agencies would not fire 40,000 rounds in 30 years. According to experts and trainers in the field, transition training can be accomplished with a Glock pistol in less time than a standard qualification with a S&W 4566 because the Glock operating system is many times simpler than that of the S&W 4566.

Other differences in specifications are minor.

The S&W 4566TSW is an obsolete weapon. The weapons that the State Police currently use, the 4566 are less than 10 years old. Maybe that is why they are obsolete.
