



The West Virginia Office of Technology (WVOT) is requesting quotations from qualified, manufacturer-authorized, vendors to provide a data center infrastructure equipment price list based on an enterprise (fabric-switched) data center switch, several fabric extenders for top-of-rack deployment, a data center class firewall, a load-balancing appliance and interconnecting interface modules and cable assemblies.

The WVOT is currently looking to consolidate multiple servers, from various agencies in our data center. These servers may be equipped with Gigabit Ethernet interfaces, 10 Gigabit Ethernet interfaces, or in some cases, 100 Mbps interfaces. The Nexus switch "or equal" and fabric extenders are being specified in order to prepare the data center infrastructure to accommodate both the current growth in servers, and the migration to higher density 10 Gigabit Ethernet connectivity in the future. In addition, high-performance firewall and load balancing appliances are being specified in order to accommodate ever-increasing security requirements and traffic volumes.

The model/brand specifications named herein establish the acceptable level of quality only and are not intended to reflect a preference, or to favor any particular brand or vendor. This RFQ specifies Cisco name brand products, "or equal" specifically for the following reason: The products we are requesting for purchase are an expansion and upgrade to our existing data center hardware and system architecture. Any alternative products must seamlessly fit into, integrate with and interchange with the existing Cisco infrastructure investment with zero loss of feature, functionality and no infrastructure configuration changes. Vendors who are bidding alternates should so state and include pertinent literature and specifications. Failure to provide information for any alternates may be grounds for rejection of bid.

There are no installation or training charges involved in this RFQ, equipment list pricing only with manufacturer warranty and delivery.

This list of equipment is considered to be part of a WVOT upgrade not available from statewide contracts. Vendors must bid new equipment and provide a pricing list for the line itemized bid price sheet of equipment, licenses and contracts and shipping charges.

- Bidder is a resident vendor who certifies that, during the life of the contract, on average at least 75% of the employees working on the project being bid are residents of West Virginia who have resided in the state continuously for the two years immediately preceding submission of this bid; **or,**

3. Application is made for 2.5% resident vendor preference for the reason checked:

- Bidder is a nonresident vendor employing a minimum of one hundred state residents or is a nonresident vendor with an affiliate or subsidiary which maintains its headquarters or principal place of business within West Virginia employing a minimum of one hundred state residents who certifies that, during the life of the contract, on average at least 75% of the employees or Bidder's affiliate's or subsidiary's employees are residents of West Virginia who have resided in the state continuously for the two years immediately preceding submission of this bid; **or,**

PURCHASING AFFIDAVIT

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate.

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

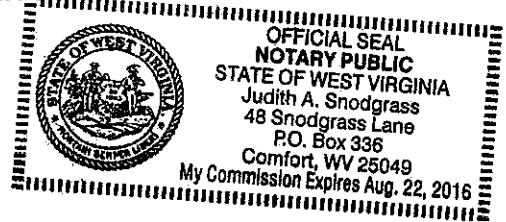
