1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services.
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.

**OPEN END CONTRACT - SEWER PUMPING SERVICES  
LAKIN CORRECTIONAL CENTER**

Lakin Correctional Center is requesting bids for the costs of pumping and proper disposal of facility's sewer storage systems and water blasting/jetting of sewer lines. The sewer systems to be pumped include:

2,000 Gallon Spillover Tank  
3,500 Gallon Lift Station  
5,000 Main Sewer Station

Pumping services will be on an approximate Bi-monthly basis. Lakin Correctional Center will schedule service dates with vendor. Water blasting jetting of sewer lines will be on an as needed, on-call basis.

The rate of pay for pumping and disposal of sewer systems should be quoted as price per trip for each individual system (Spillover tank, Lift station and Main station). The rate of pay for water blasting/jetting sewer lines will be based on an hourly rate to include travel time.

Service rates will be based on a Monday through Friday, excluding holidays, 8:00 AM to 4:00 PM basis.

Vendor must also quote pricing for emergency call-out service for both pumping/disposal and water blasting/jetting lines on an as needed basis. Emergencies include after normal business hours, weekends and holidays.

Vendor must be at the LCC facility within 4-5 hours after emergency call out.

Evaluation and award will be made to the responsive and responsible vendor meeting specifications at the grand lowest bid.
