### **GENERAL TERMS & CONDITIONS** REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.

3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division

and have paid the required \$125 fee.

- 4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Furchase Order/Contract becomes void and of no effect after June 30.
- 5. Payment may only be made after the delivery and acceptance of goods or services.
- 6. Interest may be paid for late payment in accordance with the West Virginia Code.
- 7. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 10. The laws of the State of West Virginia and the Legislative Rules of the Purchasing Division shall govern the purchasing process.
- 11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
- In the event the vendor/contractor files for bankruptcy protection, the State may deem 12. BANKRUPTCY: this contract null and void, and terminate such contract without further order.
- 13. HIPAA BUSINESS ASSOCIATE ADDENDUM: The West Virginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, is available online at www.state.wv.us/admin/purchase/vrc/hipaa.htm and is hereby made part of the agreement. Provided that the Agency meets the definition of a Cover Entity (45 CFR §160.103) and will be disclosing Protected Health Information (45 CFR §160.103) to the vendor.
- 14. CONFIDENTIALITY: The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency's policies, procedures, and rules. Vendor further agrees to comply with the Confidentiality Policies and Information Security Accountability Requirements, set forth in http://www.state.wv.us/admin/purchase/privacy/noticeConfidentiality.pdf.
- 15. LICENSING: Vendors must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State's Office, the West Virginia Tax Department, and the West Virginia Insurance Commission. The vendor must provide all necessary releases to obtain information to enable the director or spending unit to verify that the vendor is licensed and in good standing with the above entities.
- 16. ANTITRUST: In submitting a bid to any agency for the State of West Virginia, the bidder offers and agrees that if the bid is accepted the bidder will convey, sell, assign or transfer to the State of West Virginia all rights, title and interest in and to all causes of action it may now or hereafter acquire under the antitrust laws of the United States and the State of West Virginia for price fixing and/or unreasonable restraints of trade relating to the particular commodities or services purchased or acquired by the State of West Virginia. Such assignment shall be made and become effective at the time the purchasing agency tenders the initial payment to the bidder.

# REQUEST FOR QUOTE

#### **Building Maintenance Services**

The Public Service Commission of West Virginia (PSCWV) is requesting bids for the services of a vendor to perform certain maintenance, upkeep and emergency and/or temporary repairs to the Commission's buildings (all property presently owned by the PSCWV), and the building's offices and contents.

The scope of this contract is generally restricted to "odd-job" services; those items that are too small in scope or cost to warrant separate bidding, and shall include all services, labor and hand tools to complete any and all assignments under this contract

The PSCWV is a state agency responsible for the regulation and oversight of all public and private utilities operating within the state of West Virginia. The PSCWV's sole office facility is located at 201 Brooks Street, Charleston, West Virginia. This office facility is a three-story, flat-roofed, brick and glass building of approximately 56,000 square feet with approximately 200 offices, one small and one large hearing room, 10 restrooms, two elevators and three, three-story atriums. The on-site parking lot has a three story parking garage (which will require work not covered by warranty including lighting, plumbing and electrical) and a parking lot which will accommodate approximately 50 cars. Approximately 95% of the building is carpeted. The balance of the floor space is either covered with finished oak or marble. The walls are of dry wall construction over aluminum studding with drop ceilings. There is significant electrical and communication wiring throughout the building's walls and above the drop ceiling (all employees have personal computers, internet/intranet connections, and telephones). The heating and cooling system is covered by a separate maintenance agreement and is not a part of this contract, however the vendor will sometimes be required to assist in emergencies and will need to have general knowledge of the chiller and boiler room and assist with replacing filters if necessary.

A second building, which is located beside the main office building, is a three story brick building of approximately 15,000 square feet which will hold approximately 30 to 40 employees. The building is carpeted with dry wall construction and drop ceilings and has a flat roof. All employees in this building also have personal computers, internet/intranet connections and telephones. The heating and cooling system is covered by a separate maintenance agreement and is not a part of this contract, however, the vendor will sometimes be required to assist in emergencies and will need to have general knowledge of the chiller and boiler room and assist with replacing filters if necessary.

The vendor shall be licensed, insured, bonded and certificated as required by State and local regulations and law to perform any and all building maintenance, and any and all building repair, alteration and modification as requested by the PSCWV, including electrical and plumbing. The vendor shall provide evidence of all required certificates and insurances prior to entering into the contract. The vendor shall be on call 24 hours a day, seven days a week, and, shall be prepared to respond within 24 hours of any request by the PSCWV for normal maintenance and repair items. In the event of an emergency, the vendor must respond to the premises within thirty minutes of the PSCWV's request. Vendor must be capable of overseeing all jobs and/or have enough adequate staff. There will be no subcontracting allowed. The bulk of the work will be in the evenings and weekends and sometimes required to work on a state holiday. Also there will be no overtime pay - all work is a flat rate as per quote.

All work will be inspected by the PSCWV prior to authorizing payment to the vendor. The PSCWV shall agree to process all Vendor invoices on the day received if work performed is completed in a satisfactory manner.

While the following is not intended to portray a complete listing of the possible jobs that might need to be completed, it is intended to give an idea of the nature of the possible assignments under this contract. A maintenance schedule or program will consist of:

- 1. Changing out light bulbs in 3 buildings and replacing blown breakers.
- 2. Replace ballasts when bad, end clips, heat sensors, and pinging.
- 3. General plumbing including changing deodorizers; repairing sinks, toilets & urinals; repair hand dispensers and replace batteries; clean floor drains (use drain o max); repair broken stalls, mirrors and faucets and replace wax rings.
- 4. Snack Room: unstop & clean floor; shut down, clean & change filter of the ice machine; check hot water dispenser.
- 5. Janitorial Closets clean/unstop drains
- 6. Water fountains: clean chillers out and change out water control valves
- 7. Transportation Building sewage pump sometimes has to be manually pumped to get sewage out.
- 8. Hearing Room: repair theater seating when necessary; help with dimmer

control lights; check heater where the intercoms are located to keep panel boxes from getting cold and causing speakers to crackle and ceiling lights to blink.

- 9. Replace and repaint bad ceiling tiles (cheaper to paint them)
- 10. Weed grounds and spray for bugs; pressure wash walks, driveways and parking garage (vendor must have own equipment). Clean storm drains.
- 11. Assist building manager in the removal of snow, shovel & salt (large jobs are contracted out). Usually includes breeze way and surrounding areas, handicap ramp & sidewalks (areas that can't be done by truck)
- 12. Painting/touch up as needed of stairwells, breeze ways, hand rails, steel door jams, support brackets, walls.
- 13. Move, repair and assemble furniture
- Hang bulletin boards, coat hooks and install keyboard trays
- 15. Replace/repair receptacles; sockets, switches, light timers, electrical panels and emergency lights, and blown breakers.
- 16. Mechanical Rooms: clean & touch up floors with paint
- 17. Reset electric timers on auto lights reset time clock for outside pole lights change timer boxes when time changes
- 18. Pick up supplies as needed
- 19. Elevator doors clean door slides
- 20. Repair wall heaters (have 22 in building)
- Vendor shall have general knowledge about building so to save agency money on major repairs - The maintenance program, once established, should assist the agency in preserving and maintaining all buildings.

The above list is not a conclusive list. The vendor performs these maintenance and handy man jobs and others as needed.

# **PURCHASING AFFIDAVIT**

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate.

#### **DEFINITIONS:**

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any Instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

Under penalty of law for false swearing (West Virginia Code §61-5-3), it is hereby certified that the vendor affirms and acknowledges the information in this affidavit and is in compllance with the requirements as stated.
