Request for Quotation Specifications

Purpose: To provide concrete box beams for Churchville Arch Widening Project# S304-5/6-7.31

1.0 DEFINITIONS

- A. The "Agency" shall be defined as the West Virginia Division of Highways
- B. The "Vendor" shall be defined as the successful bidder.
- C. The "Contract" shall be defined as the binding agreement that is entered into between the State of West Virginia and the Vendor to provide the services as herein specified.
- D. "Release Order" shall be defined as order placed against the Contract by the Agency.
- E. Mandatory Requirements: The terms "must", "will", "shall", "minimum", "maximum", or "is/are required" identify a mandatory item or factor. Decisions regarding compliance with any mandatory requirements shall be at the sole discretion of the State.

2.0 SCOPE OF WORK

The successful Vendor shall provide concrete box beams per attached plans for the Churchville Arch Widening project and provide for delivery to project site in Lewis Co. WV.

2.1 Technical Requirements:

3.0 ADDITIONAL NOTES

20 bridge guardrail posts with hardware, and 112.5 linear feet of guardrail will be attached to beams by fabricator. Shipping constraints may limit the length of attached guardrail. Cost for guardrail attachment shall be included in the unit bid price. Minimum concrete strengths will be 5500 psi at detention and 8000 psi at 28 days. Pre-stressing strands shall be seven-wire uncoated low relaxation oversize strand (AS=0.167 sq. in.) with a minimum tensile strength of 270,000 psi. All lab reports must accompany the shipping ticket. Delivery of 8 beams is expected within 60 days of award.

4.0 FREIGHT AND DELIVERY

4.1 Freight

- 4.1.1 All shipments are to be FOB Destination.
- 4.1.2 The Vendor shall be responsible for including freight charges in quote.

5.0 PAYMENT

5.1 Payment

PURCHASING AFFIDAVIT

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owned is an amount greater than one thousand dollars in the aggregate

DEFINITIONS:


"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, Limited Liability Company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent. of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.
