GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
- 4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
- 5. Payment may only be made after the delivery and acceptance of goods or services.
- 6. Interest may be paid for late payment in accordance with the West Virginia Code.
- 7. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
- 11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
- 12. BANKRUPTCY: In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.
- 13. Specifications 0812C0272

Purpose: To establish a contract to provide Fog Seal Emulsion to the West Virginia Division of Highways in Pendleton, Pocahontas, Randolph, and Tucker Counties of District 8.

1.0 DEFINITIONS

- A. The "Agency" shall be defined as the West Virginia Division of Highways
- B. The "Vendor" shall be defined as the successful bidder.
- C. The "Contract" shall be defined as the binding agreement that is entered into between the State of West Virginia and the Vendor to provide the services as herein specified.
- D. "Release Order" shall be defined as order placed against the Contract by the Agency.
- E. "Mandatory Requirements: The terms "must", "will", "shall", "minimum", "maximum", or "is/are required" identify a mandatory item or factor. Decisions regarding compliance with any mandatory requirements shall be at the sole discretion of the State.

2.0 SCOPE OF WORK

The successful Vendor shall provide all labor, materials and equipment necessary to supply Cationic Asphalt Emulsion used for fog seal and/or flush coat on various types of asphalt roadways and fill agency storage tanks.

2.1 Administration of this Contract shall meet the requirements Of West Virginia Department of Transportation, Division of Highways, Standard Specifications for Roads and Bridges Adopted 2010 and Supplemental Specifications dated 2011. These Standard Specifications Roads and Bridges and the current Supplemental Specifications are available at the following website:

2.2 Freight

2.2.1 All shipments are to be F.O.B. Destination.

2.3 Delivery

Deliveries shall be made to the West Virginia Division of Highways, District 8, storage tanks or job sites located in Pendleton, Pocahontas, Randolph, or Tucker Counties. Vendor shall provide tank truck delivery to Division storage tanks or necessary labor, material and equipment to apply to various types of asphalt roadways.

2.3.1 Delivery will only be accepted during normal working hours 6:30 am to 4:00 pm, Monday – Friday.

3.0 MATERIAL REQUIREMENTS

Viscosity, Furol @ 77 F (AASHTO T 72)

O-80 seconds

O.1% max.

Residue percent (AASHTO T 59) 40% min.

Ring & Ball Softening Point (AASHTO T 53) 60-90 C

The application temperature of liquid asphalt emulsion shall be 140-180 degrees F. The application rate shall be 0.05 to 0.15 gallons per square yard.

3.1 MINIMUM QUALIFICATIONS

3.1.1 The vendor shall meet all Federal and State Laws and Regulations concerning Hazardous Chemicals.

4.0 ORDERING AND INVOICING

4.1 For all orders, the Agency will issue to the Vendor a WV-39 Release Order. Issuance of the WV-39 Release Order shall contain the quantity and type of merchandise to be purchased and shall serve as the authorization to begin work. No work other than that specified in the Release Order shall be undertaken by the Vendor.

- 4.2 Vendor's invoices must contain the following:

PURCHASING AFFIDAVIT

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate.

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.
