**PURCHASING AFFIDAVIT**

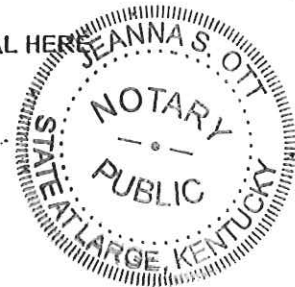
