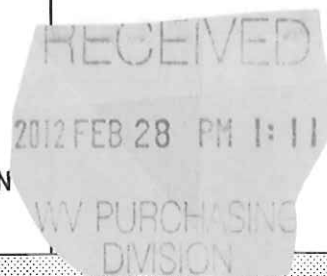

## GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

1. Awards will be made in the best interest of the State of West Virginia.
  2. The State may accept or reject in part, or in whole, any bid.
  3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
  4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
  5. Payment may only be made after the delivery and acceptance of goods or services.
  6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
  7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
  8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
  9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
  10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
  11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
  12. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.

The following comments and questions were identified from the Pre-Bid Conference. The answers provided herein take precedence over verbal answers at the PBC should there be any conflict between the two.

Questions:

Site 1

1. Q. Is there material available on-site to backfill the highwall?  
A. Yes.
2. Q. Is the length for the pipe in the bat gate mine seals known?  
A. Not exactly. The length required is dependent upon, and therefore somewhat determined by the conditions encountered during construction.
3. Q. Can the material from clearing and grubbing be burned?  
A. Yes. The required burning permits must be obtained.

Site 3

4. Q. How is the removal and disposal of material from eliminating Pond No. 2 paid?  
A. The excavated material is included in the pay item for "Unclassified Excavation".
5. Q. What is the access to Site 3?  
A. There are two as shown on the plans. Access to the work area to the one side of Pond No. 1 is through Site 2. Access to the other side is by an abandoned road. Culverts must be installed in this road in the locations where drainways exist to convey the drainage across it.
6. Q. Is any backfilling of the upper highwall proposed?
