REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)**

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services.
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
12. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.

The following comments and questions were identified from the Pre-Bid Conference. The answers provided herein take precedence over verbal answers at the PBC should there be any conflict between the two.

Questions:

- Q. The plans indicate that the permanent fence replacement shall be with the same type of materials as are found in the existing fence that is to be removed. What materials does the existing fence consist of?
- A. The property owner advised that the replacement fence could consist of locust posts and three strands of high tensile wire with one of the strands electrified..
- Q. What is the breakdown of the quantity for "Unclassified Excavation" per Site 1 and Site 2?
- A. Site 1 total cut = approximately 12,600 C.Y.
Site 2 total cut = approximately 39,600 C.Y.

Comments:

1. Spec. 4.2.7 shall be revised to indicate that eight inches shall apply to all timber except locust timber. For locust, the dimension shall be six inches in order to utilize the cleared timber for locust posts.
2. Bidders are advised to consider the temporary items required as per the erosion and sediment control plan in their bid. In this regard, Super Silt Fence (SSF) should replace Stabilization Matting (SM) in number 10 of structural practices on Sheet 20.
3. The performance capabilities for the Excelsior Type I Curlex Matting or approved equal are as follows: shear stress to 84 Pa (1.75 lb/ft²).

The Contractor shall have 120 days from the date of the Notice to Proceed to complete construction activities on the project. The \$250.00 per day liquidated damages clause will be in effect after the 120 days. 
