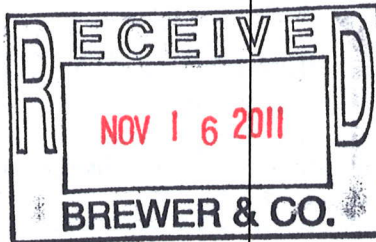

During the prebid today I noticed the roof deck was of wood timber construction with a slope greater than 2 in 12. Normally timber frame construction is not considered to be a smooth surface per NFPA which eliminates the use of dry sidewalls.

- Per NFPA 13 8.4.2 sidewall sprinklers shall only be installed as follows light hazard occupancies with smooth horizontal or sloped flat ceilings

(We) would recommend using brass upright sprinklers feed by an antifreeze loop. This would be a more cost effective way to protect the canopies versus a dry system. Please advise?

RESPONSE: Item #9 is revised to state: "Vendor must install four brass upright sprinklers fed by an antifreeze loop."

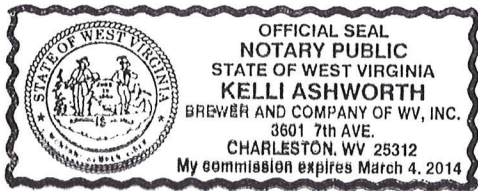




