GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
- 4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
- 5. Payment may only be made after the delivery and acceptance of goods or services.
- 6. Interest may be paid for late payment in accordance with the West Virginia Code.
- 7. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 10. The laws of the State of West Virginia and the Legislative Rules of the Purchasing Division shall govern the purchasing process.
- 11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.

ADDENDUM #1 DNR212113

On page 1 of the requisition change the number of trucks from one (1) to two (2).

Question 1:

The ratio requested is 3.91 to 1.0; with the requested overdrive transmission FRO-11210-C, the maximum speed on this unit is 91 mph. We can set the electronics to a maximum of 75 mph or, would the buyer prefer a higher numerical ratio to slow the top speed down?

Answer 1:

The specification doesn't change. The required gear ratio is 3.91. If necessary, electronics can be set to limit top speed to 75mph.

Question 2:

There is no clutch specified.

Answer 2:

The clutch needed must be of a capacity to support the 10-speed transmission and torque capacity of engine.

Question 3:

The bid request is for 36,000 lb. GVWR; there is no way to get to this number using 11R22.5/G ply tires. This would rate to only 12,350 lbs added to the rear of 23,000 lbs, which equals 35,350 lbs. Suggest the bid be amended to 11R22.5/H ply tires which will give you 13,220 lbs. Add 23,000 lbs. for the rear and the total should be 36,220 lbs.

Answer 3:

Tire ply can be amended to 11R22,5/H.

Question 4:

Do you desire the **0.472**" /8.25 DC / 5-hand hole /Hub Piloted rims that are being spec'd by the WVDOH? If so, this should be specified on the request.

Answer 4:

No; rims should be bid as specified.

Question 5:

Is the spare tire you desire should be the same Mud and Snow pattern as the rear tires?

Answer 5:

Spare tire should match front tire pattern.

Question 6:

Our dual outside mirrors have an integral convex section. They are 7.09" x 15.75" with heated heads, thermostatically controlled, and power both sides Flat Glass only with clearance lights, LED. Will this meet the specification stated in the bid?

Answer 6:

Yes, Clarification on dimensions for outside mirrors are to be minimum 7" x maximum 16". Integral convex EXCEPTION: INTERNATIONAL TRUCK OFFERS ONLY section will meet specifications listed. 7.09" x 15.75" MIRROR PER SPEC SUPPLIED

Question 7:

As a note, the Dura Star 4400 as indicated does not offer the MaxxForce 9 engine lineup. This will be the WorkStar 7500 series.

Answer 7:

The engine bid must meet the specifications as written.

Question 8:

I have a technical question. I want to bid a Ford F-750. The truck will meet most of the specs of the bid. However, The biggest engine available is a Cummins 6.7L 409 cubic inch engine. Horsepower is 325 @ 2300 rpm and torque is 750 ft. lbs @ 1800.00 rpm. Ford does not offer a 10speed transmission. The transmission would be a Fuller 6-Speed manual with overdrive. GVW will be 36,000 lb. Will this work?

Answer 8:

Minimum specification is 10-speed transmission with 950 pounds of torque.

Question 9:

I need to know the weight of the load of the truck.

Answer 9:

Actual weight of truck will vary, depending on type of tank construction - aluminum, fiberglass, or wood, and the number of tank compartments. As specified, 36,000 GVWR will accommodate the various loads.

Question 10:

I do have one additional question since it appears that you have purchased this truck before. What is the frame that you are using with this body setup? Was it an 80,000 psi rail or a 120,000 psi rail?

Answer 10:

This is a new requisition. Please bid in accordance with specifications.
