REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services.
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
12. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.

Vendor to provide slaughtering and commercial processing of beef delivered by the West Virginia Department of Agriculture on hoof. The number of beef delivered will vary from 5-10 per month.

Vendor to keep the animal hides, heads, entrails, feet and neck bones and discard tongue and heart after processing.

Vendor will contact St. Marys Correctional Center for processing instructions. Processed meat to be packed, frozen and stored below 40 degrees and delivered 10 days after receiving delivery of beef to be processed from the Department of Agriculture.

Ground Beef (90/10) must be twice ground and packed in 10 pound bags.

Ground Beef Patties (90/10) must be ground twice and packed in 50 pound packages with paper between each patty for easy separation.

Beef Roasts must be boneless and 80% fat trimmed and packed in 10 lb. packages.

Liver must be packed in 10 lb. packages

All meat packages must be labeled with product description, weight and count and date processed.

Specific processing instructions will vary from month to month depending on the amount of meat ordered and the need of the facility. The instructions will be provided in writing, on a monthly basis to the vendor by Billie Slonaker, Kitchen Supervisor.

Delivery hours are between 8:00 am and 3:30 pm, Monday-Friday. Holidays to be determined when the processing company is open. Thanksgiving-Christmas and New Year's will be delivered either the day before or day after unless the holiday falls on the weekend then it is to be delivered on the Friday before or the Monday after.

All deliveries will be received in the South Sally Port of the facility and will be FOB Destination.

All quotations must include the slaughtering charge and itemized pricing for each process as well as any delivery fees.

The vendor will be dropping off the meat at the kitchen and inmates will be unloading the product from the truck.
