Thanks for the opportunity to provide you with the attached response to RFP EBA465. This cover letter will serve as part of our response.

Here are RCS specific quotation responses by specification:

19. DELIVERY: All quotations are considered freight on board destination ("F.O.B. destination") unless alternate shipping terms are clearly identified in the bid. Vendor's listing of shipping terms that contradict the shipping terms expressly required by this Solicitation may result in bid disqualification,

RCS RESPONSE: RCS's terms are payment due following the completion of RCS training not to exceed thirty (30 days) after delivery.

23. TAXES: The Vendor shall pay any applicable sales, use, personal property or any other taxes arising out of this Contract and the transactions contemplated thereby. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.

RCS RESPONSE: RCS will need a state exemption certificate or sales tax will be applied to invoices.

#### 1. PURPOSE AND SCOPE:

....Upon failure of the main studio, operation would commence from this backup facility. Depending on the type of failure staff would either update the system from the studio, or if the failure is severe enough would then deploy to a facility which has internet access and resume operation from there. The backup system would have to dynamically synchronize with the main system to make the transition as seamless as possible abod

RCS RESPONSE: Comply



An assumption is made that during an event such as this the news department would become the driving element for the broadcast. They would need the ability to seize control and pre-empt existing programming from any location that has internet access. Since there are several news bureaus some sort of system would need to be in place for coordination-the test model would be no cell phones, no telephone contact- all communication and posting done from a laptop at a wifi hotspot.

**RCS RESPONSE**: It is possible to control the automation software via a laptop but audio switching has not been specified by WVEBA.

RCS RESPONSE: RCS can provide this overall capability. A thorough planning discussion with WVEBA would be necessary to identify possible solutions. This could require additional hardware supplied by WVEBA not included in RCS' bid totals.

> 3.1.2.2.1 A temporary news operation may need to be established at a location with no other asset than a WIFI connection

RCS RESPONSE: While RCS does not currently offer this capability, testing for its development is scheduled to start for it in October.

3.1.2.2.2 Newsroom software will supply the connection and security for emergency operations

RCS RESPONSE: RCS offers password protection.

3.1.2.3 A field reporter may be required to utilize an iPhone or Smartphone to broadcast a news report from a remote location

RCS RESPONSE: RCS can interface with several types of audio switchers/routers for pass-through although none have been specified so none are included in the RFQ pricing.

RCS understands the requirement of time shift as meaning playback from hard drive of PRSS Content Depotdelivered programming. Alternately, real time programming may be recorded for later playback with additional hardware and software at additional expense not included in this quote.

#### AGREEMENT ADDENDUM FOR SOFTWARE

In the event of conflict between this addendum and the agreement, this addendum shall control:

- 1. <u>DISPUTES</u> Any references in the agreement to arbitration or to the jurisdiction of any court are hereby deleted. Disputes arising out of the agreement shall be presented to the West Virginia Court of Claims.
- 2. HOLD HARMLESS Any provision requiring the Agency to indemnify or hold harmless any party is hereby deleted in its entirety.
- GOVERNING LAW The agreement shall be governed by the laws of the State of West Virginia. This provision replaces any references to any
  other State's governing law.
- 4. TAXES Provisions in the agreement requiring the Agency to pay taxes are deleted. As a State entity, the Agency is exempt from Federal, State, and local taxes and will not pay taxes for any Vendor including individuals, nor will the Agency file any tax returns or reports on behalf of Vendor or any other pany.
- 5. PAYMENT Any references to prepayment are deleted. Fees for software licenses, subscriptions, or maintenance are payable annually in advance. Payment for services will be in arrears.
- 6. INTEREST Any provision for interest or charges on late payments is deleted. The Agency has no statutory authority to pay interest or late fees.
- 7. NO WAIVER Any language in the agreement requiring the Agency to waive any rights, claims or defenses is hereby deleted.
- FISCAL YEAR FUNDING Service performed under the agreement may be continued in succeeding fiscal years for the term of the agreement continued in point independent upon finds being appropriated by the Legislature or otherwise being available for this service. In the event funds are not appropriated or otherwise available for this service, the agreement shall terminate without penalty on June 10. After that date, the agreement becomes of no effect and is null and void. However, the Agency agrees to use its best efforts to have the arguments contemplated under the agreement included in its budget. Non-appropriation or non-funding shall not be considered an event of default.
- 9. STATUTE OF LIMITATION Any alauses limiting the time in which the Agency may bring suit against the Vendot, lessor, individual, or any other party are deleted.
- 10. SIMILAR SERVICES Any provisions limiting the Agency's right to obtain similar services or equipment in the event of default or non-funding during the term of the agreement are hereby deleted.
- FEES OR COSTS The Agency recognizes an obligation to pay attorney's fees or costs only when assessed by a court of competent jurisdiction.

  Any other provision is invalid and considered null and void.
- 12. ASSIGNMENT Notwithstanding any clause to the contrary, the Agency reserves the right to assign the agreement to another State of West Virginia agency, board or commission upon thirty (30) days written notice to the Vendor and Vendor shall obtain the written consent of Agency prior to assigning the agreement.
- 13. LIMITATION OF LIABILITY The Agency, as a State entity, cannot agree to assume the potential liability of a Vendor. Accordingly, any provision in the agreement limiting the Vendor's liability for direct damages is hereby deleted. Vendor's liability under the agreement shall not exceed three times the total value of the agreement. Limitations on special, incidental or consequential damages are acceptable. In addition, any limitation is null and void to the extent that it precludes any action for injury to persons or for damages to personal property.
- 14. RIGHT TO TERMINATE Agency shall have the right to terminate the agreement upon thirty (30) days written notice to Vendor. Agency agrees to pay Vendor for services rendered or goods received prior to the effective date of termination. In such event, Agency will not be entitled to a refund of any software linease, subscription or maintenance fees paid.
- 15. TERMINATION CHARGES Any provision requiring the Agency to pay a fixed amount or liquidated damages upon termination of the agreement is hereby deleted. The Agency may only agree to reimburse a Vendor for actual costs incurred or losses sustained during the current fiscal year due to wrongful termination by the Agency prior to the end of any current agreement term.
- 16. RENEWAL Any reference to automatic renewal is deleted. The agreement may be renewed only upon multial written agreement of the parties.
- 17. INSUKANCE Any provision requiring the Agency to purchase insurance for Vendor's property is deleted. The State of West Virginia is insured through the Board of Risk and Insurance Management, and will provide a certificate of property insurance upon request.
- 18. RIGHT TO NOTICE Any provision for repossession of equipment without notice is hereby deleted. However, the Agency does recognize a right of repossession with notice.
- 19. ACCELERATION Any reference to acceleration of payments in the event of default or non-funding is hereby deleted.
- 20. CONFIDENTIALITY -Any provision regarding confidentiality of the terms and conditions of the agreement is hereby deleted. State contracts are public records under the West Virginia Freedom of Information Act.
- AMENDMENTS All amendments, modifications, alterations or changes to the agreement shall be in writing and signed by both parties. No
  amendment, modification, alteration or change may be made to this addendam without the express written approval of the Purchasing Division
  and the Attorney General.
