PURCHASING AFFIDAVIT

MANDATE: Under W. Va. Code §5A-3-10a, no contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and: (1) the debt owed is an amount greater than one thousand dollars in the aggregate; or (2) the debtor is in employer default.

EXCEPTION: The prohibition listed above does not apply where a vendor has contested any tax administered pursuant to chapter eleven of the W. Va. "Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Employer default" means having an outstanding balance or liability to the old fund or to the uninsured employers' fund or being in policy default, as defined in W. Va. Code § 23-2c-2, failure to maintain mandatory workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

Forms World has provided your paper needs for your land book and personal property book for well over 8 years. Our goal at Forms World is to provide the best quality paper at the best price. Over the years, we have experienced quite a few complications with the Colonial paper. Our last shipment was a repeat issue with using this paper. Colonial mill will only run your paper when they have a full mill run. In additional we never know when we will not be able to purchase this paper as there has been talk of the mill no longer making this paper.

Your order was placed on November 20, 2013 with my manufacturer and they placed the order with the mill to get paper in house. This time we had an eight week wait to get paper from the mill. Once in house, we started production of your order. As this paper comes on huge rolls, there is no sign of paper splicing or other issues, until we start producing. During production it was discovered that the mill run was spliced multiple times. Your order should have been a total of 20 rolls. We actually ended up sending you 30 rolls as we did not want you to have any problem running and discover hidden splicing. We started new rolls every time we came upon a splice so that your production people would have no splicing to deal with.

We would like to offer you an option to use a paper that is readily available. This is a stock paper for our manufacturer, KDM. This paper would save you over 50% in cost. I have included with my bid, a bid for the proposed new paper and samples for consideration.

Forms World does realize that you will get more bidders with our proposed change in paper, and we hope you will consider that it was Forms World that made this suggestion. As mentioned before, it is our goal to provide the best quality and pricing for you needs.
