

Credit Management Company, CMC, is pleased to submit a quotation to the State of West Virginia to perform Debt Collection Services for all West Virginia State Agencies and political subdivisions.

CMC is a premier full service accounts receivable and collection management agency that has been in business since 1966. Our agency works with a broad range of clients in a variety of industries including government, healthcare, education and commercial. As a credible debt collection agency, we remain in strict adherence to industry regulations including FWA, FDCPA, TCPA, CFPB and the Gramm-Leach Bliley Act. We are an active advocate of our industry and we maintain memberships in many professional organizations such as the Association of Credit and Collection Professionals (ACA International).

We understand that the needs of our government clients are unique therefore we operate a separate division focused primarily on public sector debt collection. This team has been working with state and local government clients since 1997. The dedicated team will work to collect debts on behalf of the State of West Virginia.

It is our understanding that accounts will be placed with an agency after they have been worked internally for three (3) months. When accounts are placed with CMC the debtor information is imported into our sophisticated account management system and predictive analytics and skip tracing are performed. An initial notice is sent to the debtor within 24 hours of placement or upon verification of a new address. Immediately following letter notification, CMC begins telephone contact with debtors. CMC makes call attempts on every account, regardless of balance size. All initial calls are done with a live voice. Due to our extended hours, we will make attempts to contact the debtors at various points in a day including morning, daytime, and evening as well as attempts on Saturdays. On average, a debtor is contacted every ten days.

Per the mandatory requirements, all placed accounts will be worked for 180 days before being returned to the originating spending unit unless a payment plan is established. In addition, at the end of two years all accounts that are not paid in full will be referred back to the original spending unit with a litigation referral form.

CMC will send all payments collected during any month by the 15th of the following month accompanied by the report criteria outlined in section 4.1.5.3 of the Specifications. CMC is able to handle several classifications of accounts separately in order to provide performance metrics to the spending unit by class of accounts. All records will be kept for a minimum of six years.

When collecting student loan accounts, CMC will adhere to direct student loan guidelines. Additionally, CMC will gladly sign the HIPAA agreement prior to working with any State Agency bound by the Health Insurance Portability and Accountability Act of 1996.

We welcome the opportunity to work with the State of West Virginia to help you achieve your delinquent collection goals. After reading through our documents, should you have any questions or require additional information, please feel free to contact me.

PURCHASING AFFIDAVIT

MANDATE: Under W. Va. Code §5A-3-10a, no contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and: (1) the debt owed is an amount greater than one thousand dollars in the aggregate; or (2) the debtor is in employer default.

EXCEPTION: The prohibition listed above does not apply where a vendor has contested any tax administered pursuant to chapter eleven of the W. Va. Code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Employer default" means having an outstanding balance or liability to the old fund or to the uninsured employers' fund or being in policy default, as defined in W. Va. Code § 23-2c-2, failure to maintain mandatory workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

AFFIRMATION: By signing this form, the vendor's authorized signer affirms and acknowledges under penalty of law for false swearing (*W. Va. Code* §61-5-3) that neither vendor nor any related party owe a debt as defined above and that neither vendor nor any related party are in employer default as defined above, unless the debt or employer default is permitted under the exception above.
