SPECIFICATIONS

- 1. **PURPOSE AND SCOPE:** The West Virginia Purchasing Division is soliciting bids on behalf of the WEST VIRGINIA DEPARTMENT OF REVENUE for an experienced vendor to provide research and analytical services necessary to complete a comprehensive study requested by the legislature relating to the fiscal and budgetary impact of state subsidized greyhound racing.
- 2. **DEFINITIONS:** The terms listed below shall have the meanings assigned to them below. Additional definitions can be found in section 2 of the General Terms and Conditions.
 - 2.1 "Contract Services" or "Consulting Services" means research and fiscal analysis services necessary for a comprehensive study on the fiscal impact of state subsidies to greyhound racing and any other services required to accomplish the current directive or future directives from the legislature relating to this study.
 - **2.2**. "**Pricing Section**" means the pages upon which Vendor should list its proposed price for the Contract Services.

- **5.2 Pricing Section:** Vendor should complete the Pricing Section by providing a total price for all services that includes all travel costs and incidental expenses. - 6. **PERFORMANCE:** Vendor and Agency shall agree upon a schedule for performance of Contract Services and Contract Services Deliverables, unless such a schedule is already included herein by Agency. In the event that this Contract is designated as an open-end contract, Vendor shall perform in accordance with the release orders that may be issued against this Contract.
- 7. **PAYMENT:** Agency shall pay an hourly rate, as shown on the Pricing Pages, for all Contract Services performed and accepted under this Contract. Vendor shall accept payment in accordance with the payment procedures of the State of West Virginia.
- 8. TRAVEL: Vendor shall be responsible for all mileage and travel costs, including travel time, associated with performance of this Contract. 4.1.1 RESEARCH AND INDEPENDENT OBJECTIVE ANALYSIS OF GOVERNMENT SUBSIDY TO GREYHOUND RACING SHALL INCLUDE:

4.1.1.1 HISTORICAL ASSESSMENT REVIEW AND FIVE (5) YEAR PROJECTED ANALYSIS OF THE ECONOMIC STRUCTURE AND PERFORMANCE OF THE EXISTING INDUSTRY IDENTIFYING OPPORTUNITIES AND CHALLENGES

- a. Spectrum Gaming proposes to analyze the trends in the West Virginia greyhound racing industry to assess changes in amount wagered at the racetracks, purses paid (average daily and annually) and direct greyhound race track employment for prior five years
- b. If the data is available, we propose to also analyze
 - i. The profit and loss of each greyhound track broken down between casino operations and racing operations
 - ii. Racing operations revenue at each track broken down between racing and non-racing
- c. Spectrum Gaming will also produce an assessment to the non-racing participants in the industry, including breeders, farms and feed stuff
- d. Spectrum Gaming will prepare a five year analysis showing the sources of revenue for purse awards, broken down between the casino VLT subsidy, live handle and other
- e. A five year analysis of purse payments to WV residents and non-WV residents
- f. Analyze the purse winnings to deter f. Analyze the purse winnings to determine if there is a concentration among the top breeders/owners
- g. Spectrum Gaming will present an analysis projecting trends in greyhound racing handle, purses and attendance



- Spectrum Gaming will review practices in other states with greyhound racing operations to identify opportunities in West Virginia
- i. Spectrum Gaming will assess the challenges to the industry, including the presence of advocacy groups pushing to end greyhound racing and alternative entertainment options.

4.1.1.2 ASSESSMENT OF POTENTIAL CHANGES AND ECONOMIC BUDGET EFFECTS BY MODIFYING OR REPEALING LIVE RACING REQUIREMENTS FOR GREYHOUND RACING FACILITIES INCLUDING EVALUATION OF IMPACTS ON PURSES, AWARDS, AND SUBSIDIES.

- 1. Spectrum Gaming would assess if racetracks would offer fewer racing days if the requirements were modified or repealed. Our analysis would also assess changes to average daily purses and VLT subsidies.
- 2. Spectrum will evaluate alternative uses of VLT subsidy funding for the greyhound industry or the state.

4.1.1.3 THE FISCAL ANALYSIS SHALL EVALUATE ECONOMIES OF LEVERAGING EQUITY AND PROFITS AS SOURCES FOR PUBLIC FUNDING AND UNDERWRITING RISKS.

- 1. We will review data related to:
 - a. Tax revenue to WV from the state's casinos
 - b. Tax-Exempt bonds issued by municipalities backed by gaming and/or lottery revenue
- 2. Evaluate the impact to the state's borrowing capacity based on issuing bonds backed by the gaming revenue

4.1.1.4 STUDY SHALL ADDRESS AND MAKE RECOMMENDATIONS ON THE FOLLOWING:

- 1. Assess size and financial costs of regulating greyhound racing
 - a. Historical regulatory costs and employment by government agencies overseeing greyhound racing
- 2. Net costs against tax revenue from the greyhound industry to determine the net benefit (loss) to the state from regulating the greyhound industry
- 3. Consider non-financial costs and benefits



4.1.1.4.1 DETERMINE IF THE BENEFITS OF REGULATION JUSTIFY THE COST

4.1.2 Methodology: Analysis shall describe any sources of variation including but not limited to inputs to the study's fiscal impact models or calculations uses to estimate fiscal impacts.

1. Highlight potential indirect other costs to West Virginia from repealing live racing requirement, including the elimination of direct employment at the greyhound tracks, as well as the non-racing impact to greyhound farms, West Virginia bred dogs and the indirect impact of breeding operations

NOTE: Our ability to meet the December 31, 2014 deadline is contingent upon all data requests being fulfilled within no more than 3 business days.

Our methodology is quite simple, and has been proven to be very effective as well. As we demonstrated in our recent pari-mutuels reports, we plan to conduct extensive and intensive interviews in West Virginia with as many stakeholders as possible. Spectrum plans to have two key senior research staff on the ground in West Virginia upon engagement. The purpose of these meetings will be to develop an understanding of how the greyhound racing industry in its various facets has impacted stakeholders.

This approach requires that we be in full listen mode at all times, hearing and understanding the views and concerns of all those whom we interview. This approach has worked in Iowa and numerous other states, including Florida.

Notably, our work in Florida – resulting in a massive report of more than 700 pages, which was highly public and widely scrutinized – continues to be put to good use, and has not been challenged by proponents of greyhound racing.

Spectrum will deliver our impact study and recommendations to the Department of Revenue on or before December 31, 2014. Spectrum will produce and deliver six (6) copies of the study, color printed and bound in a three-ring binder and shall also be copied and provided on a CD.

The authors of the study shall be available to discuss the study in person with the Department of Revenue Cabinet Secretary and to present the study to the Legislature, if required.
