

PURCHASING AFFIDAVIT

MANDATE: Under W. Va. Code §5A-3-10a, no contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and: (1) the debt owed is an amount greater than one thousand dollars in the aggregate; or (2) the debtor is in employer default.

EXCEPTION: The prohibition listed above does not apply where a vendor has contested any tax administered pursuant to chapter eleven of the W. Va. Code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Employer default" means having an outstanding balance or liability to the old fund or to the uninsured employers' fund or being in policy default, as defined in W. Va. Code § 23-2c-2, failure to maintain mandatory workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

AFFIRMATION: By signing this form, the vendor's authorized signer affirms and acknowledges under penalty of law for false swearing (*W. Va. Code* §61-5-3) that neither vendor nor any related party owe a debt as defined above and that neither vendor nor any related party are in employer default as defined above, unless the debt or employer default is permitted under the exception above.

NOTES:

- 1) Line 4 reads "2 PIECES AT 4 FEET X1 FOOT 2 3/4 INCH X 21 FEET". Quote presumes this is actually the "Lagging plates" and should read "2 Pieces PL 3/4 x 4'-0" x 21'-0". Weight is correct at 5145 lbs.
- 2) Line 8 calls for 75 high strength bolts (ASTM A325) 3/4 x 2". These bolts will barely be long enough for use on the outsides of the structure (where the bolt goes through the W10x100 and only one diaphragm) but will not work on the center beams where the bolt must go through the W10x100 and two diaphragms. Our quote therefor includes
- 30 each 3/4 x 2 1/4 A325 bolts with two flat washers and one nut
- 45 each 3/4 x 2 3/4 A325 bolts with two flat washers and one nut We are providing two flat washers with each bolt due to the fact that the holes are oversized (7/8") and from experience we also know that by using two washers, one under the nut and one under the head of the bolt it is less likely that the galvanized surfaces will be damaged during installation of the diaphragms.
- 3) All hardware quoted Domestic with Rotational Capacity testing reports
- 4) All Steel quoted shall be domestic "melted and manufactured in USA" with MTR's and Charpy v-notch testing
- 5) All welding preformed by welders certified to AWS D1.5 Bridge Code
