KONE has provided a separate KMM (KONE Maintenance Methods) Schedule & Plan, including our Task & Procedure Guide for our technicians. (For the FBI – CJIS use only).

The Six (6) Montgomery Hydraulic Elevators are the OEM equipment of KONE Elevators and Escalators. KONE maintains the original job file for this installation and as OEM. All parts purchased by Providers other than KONE are bought at a premium.

The KMM Plan provided includes annual frequency, and will be adjusted so the KONE Inc. will be on-site monthly.


