Dear Ms. Lyle,

Aramark<sup>TM</sup> Correctional Services is pleased to participate in in your solicitation for commissary services within the West Virginia Division of Corrections. Our proposal has been carefully constructed with the objectives of increasing revenue for the Division and inmate satisfaction. As you will note, we have strategically reduced the current cost of products in some categories. We look at inmate commissary as a retail business and have used the philosophy in our cost proposal. We see value as a key to a successful business and commissary is no different. We understand this through our 35 years in corrections and more than 75-year history as a leader in the retail space. We believe that in order to be successful, you must have the products consumers want, at a price that is fair, when and where they want them with opportunities for something special. Creating value is something we are passionate about.

The menu provided addresses the products served in your commissary business today and uses our insights and analytics from our experience to help you improve the business and offenders you serve. Aramark looked at data in more than 100 commissaries we currently operate, combined with the more than \$1 billion in Aramark retail sales, paired with learnings from the overall retail convenience and grocery industry in order to create our cost proposal.

#### **Lowering Core Products and Categories**

We carefully examined your menu and identified more than 80 core items that have high acceptance in our commissary locations across the United States. In the West Virginia system, these items represent almost 20 percent of your entire menu and generated an estimated \$3,687,097.70 in annual sales. The following key categories will see a significant improvement in pricing:

- 1. Snack chips, assorted, family size, which represented estimated annual sales of \$823,000, will incur a 21 percent decrease in pricing.
- 2. Assorted cereal, representing \$838,000 in estimated annual sales, will incur a 7.7 percent decrease in the retail price.
- 3. All ramen noodles will decrease in price by 15 percent, offering offenders' savings on one of the top-selling products.

Overall, this proposed menu will lower the more than 80 core items an average of 17.5 percent and based on our assumptions on item sales will save an estimated \$461,000 annually. With the value added from lower prices, our newly designed stores, iCare, and other services, you will see inmates spend more and engage faster with the new commissary experience. The following bullets illustrate how Aramark differentiates itself from its competitors in the commissary market:

- Sales insights Aramark's point-of-sale technology is designed to efficiently categorize sales in different ways. We examine overall sales and rank each product as well as examine sales by facility and even by living unit, if needed. Since space is a premium in every facility, as it is in retail on the outside, you need to make the best use of space so we continually look at the performance to ensure high-moving items are given more space while lower-performing items are reduced or removed.
- 2. Offender Insights Aramark is the only commissary provider in the corrections space that performs focus groups with the offenders. Our marketing organization is trained on Focus Group execution and performs them annually in facilities to understand what needs are top of mind, how we can improve the commissary, and specifically what products need to stay and go. As noted in the sales insights section, we do recommend regularly changing products, but what you add in is more important to know than what you take out. Our team provides a very detailed and comprehensive study that allows the facility to understand what we are suggesting.
- 3. External Retail Research and Experience Aramark currently manages more than \$1 billion in retail sales, which includes more than \$120 million in convenience stores within colleges and universities, stadiums and arenas, and hospitals around the United States. Collectively, we all work on gathering insights from these channels and use our network of suppliers and manufacturers that service convenience and grocery stores to identify category trends, new products, and pricing strategies that are creating better participation and engagement.

If selected as the commissary provider for the West Virginia Division of Corrections, you will see an increase of sales by 38 percent, which means an increase of \$258,000 per year in revenues for the Division. In addition, the inmates will see a 17.5 percent reduction in the cost of commissary items.

We look forward to further discussions regarding how Aramark and the Division can work together to provide a state-of-the-art commissary program for the inmates in West Virginia.

### FINANCIAL/LEGAL PLAN

Aramark Correctional Services has developed the following financial plan that addresses, in detail, the needs of West Virginia Division of Corrections. The criteria used in the development of this plan are as follows:

#### NO JOINT VENTURE

It is agreed that nothing contained in this proposal or resulting contract will be deemed or construed as creating a partnership or joint venture between West Virginia Division of Corrections and any other party, or cause either party to be responsible in any way for the debts or obligations of the other party. Aramark will perform their services as an independent contractor, and nothing contained herein will be construed as placing Aramark in the category of merit employee, exempt employee, or other type of employee of West Virginia Division of Corrections.

#### TERMINATION

As the solicitation did not address termination language, Aramark would like to discuss with the Division of Corrections and for the Division of Corrections to consider the following termination language for possible inclusion in a final agreement with Aramark.

- A. **TERMINATION FOR CONVENIENCE**: Either party may terminate this Agreement for convenience, at any time during the term or any renewal or extension, upon ninety (90) days notice to the other party.
- B. **TERMINATION FOR DEFAULT:** Either party may terminate this Agreement upon a breach or default of this Agreement by the other party, which is not cured within thirty (30) days after receipt by the defaulting party of a notice from the non-defaulting party, specifying the nature of such breach or default.
- C. **CONSEQUENCES OF TERMINATION:** If this Agreement is terminated under any circumstances, the West Virginia Division of Corrections shall pay Aramark for all services provided by Aramark up to and including the date of termination, at the rates and within the payment periods set forth in this Agreement. The West Virginia Division of Corrections's obligation to pay for services provided shall survive the termination or expiration of this Agreement.

Upon the expiration or any termination of this Agreement, the West Virginia Division of Corrections and Aramark agree to discuss the option for the Division to purchase Aramark's usable inventory of products and supplies. The purchase price for such inventory shall be Aramark's invoice cost.

#### **WATERIAL ADVERSE CHANGE**

The financial arrangements in this Agreement are based on conditions existing as of the Effective Date including any representations regarding existing and future conditions made by West Virginia Division of Corrections in connection with the negotiation and execution of this Agreement. If such conditions change due to causes beyond Aramark's control, including, but not limited to, a change in the scope of Aramark's services; a decrease in the Facility's offender population or the availability of offender labor; efforts to organize labor; increases in food, fuel, equipment, utilities and supply costs; Federal, State and local sales, and other taxes and other operation costs; a change in Federal, State and local standards, requirements recommendations, and regulations; or other unforeseen external market conditions outside Aramark's control, then Aramark shall give West Virginia Division of Corrections written notice of such increase or change, and within thirty (30) calendar days after such notice, Aramark and West Virginia Division of Corrections shall mutually agree upon modification(s) to offset the impact of the increase or change, which modifications may include any or a combination of the following: an adjustment to Aramark's price per meal or commission, modifications to the product offering or pricing, or modifications to Aramark's scope of services.

#### INDEMNIFICATION

Aramark understands the Indemnification language as written in the RFP/ITB and would like to discuss with the Division of Corrections and for the Division of Corrections to consider the following suggested indemnification language for possible inclusion in a final agreement with Aramark.

Aramark agrees to defend, indemnify and hold harmless the West Virginia Division of Corrections, its officers, employees, agents and servants for all third party personal injuries caused by the gross negligence of Aramark in its performance of the services defined in this Agreement, and to pay all claims, damages, judgments, legal costs, adjuster fees and attorney fees related thereto. However, it is expressly understood that Aramark shall not be responsible for damages, injuries, losses or claims caused by offenders or the West Virginia Division of Corrections, its officers, employees, agents, servants or other independent contractors. Neither any of the West Virginia Division of Corrections's officers, employees, agents, servants or contractors, nor any offenders, are or will be deemed to be agents or employees of Aramark and no liability is or will be incurred by Aramark to such persons, except for bodily injury to such persons caused by Aramark's gross negligence. The West Virginia Division of Corrections agrees to defend, indemnify and hold Aramark harmless from any liability claim by or through such persons against Aramark. Each party shall promptly notify the other of any claim for which indemnity is sought, and shall cooperate with the other party in the defense of such claim. The indemnifying party shall have the sole discretion to defend and settle such claim. In no event will either party be liable to the other party for any loss of business, business interruption, consequential, special, indirect or punitive damages.

#### FINANCIAL COMMITMENT

Aramark shall make a financial commitment to West Virginia Division of Corrections in an amount up to \$325,000.00 (the "Financial Commitment"). West Virginia Division of Corrections agrees to invest the Financial Commitment in cosmetic improvements for the prison store locations at each on-site location. Any equipment purchased by Aramark on West Virginia Division of Corrections's behalf shall be purchased as a "sale-for resale" to the West Virginia Division of Corrections. West Virginia Division of Corrections shall hold title to all such equipment (with the exception of those items which bear the name of Aramark, its logo, or any of its logo, service marks or trademarks or any logo, service marks or trademarks of a third party) upon such resale. West Virginia Division of Corrections acknowledges that it is a tax-exempt entity and will provide Aramark with a copy of the appropriate tax-exempt certificate. The Financial Commitment shall be amortized on a straight-line basis over a period of five years, commencing upon the effective date of this Agreement. Upon expiration or termination of this Agreement by either party for any reason whatsoever prior to the complete amortization of the Financial Commitment, West Virginia Division of Corrections shall reimburse Aramark for the unamortized balance of the Financial Commitment as of the date of expiration or termination plus all accrued but unbilled interest as of the date of expiration or termination. Such interest shall accrue from the effective date of this Agreement at the Prime Rate plus two percentage points per annum, computed each accounting period on the declining balance. In the event such amounts owing to Aramark are not paid to Aramark within 30 days of expiration or termination, West Virginia Division of Corrections agrees to pay interest on such amounts at the Prime Rate plus two percentage points per annum, compounded monthly from the date of expiration or termination, until the date paid. The right of Aramark to charge interest for late payment shall not be construed as a waiver of Aramark's right to receive payment of invoices within 30 days of the invoice date. Any portion of the Financial Commitment that is not expended prior to the expiration or earlier termination of the Agreement shall revert to Aramark.

#### CONFIDENTIAL INFORMATION

All financial, statistical, operating and personnel materials and information, including, but not limited to, the Aramark System, related to or utilized in Aramark's business (collectively, the "Aramark Proprietary Information") is and shall remain confidential and the sole property of Aramark and constitutes trade secrets of Aramark. The West Virginia Division of Corrections shall keep all Aramark Proprietary Information confidential and shall use the Aramark Proprietary Information only for the purpose of fulfilling the terms of this Agreement. The West Virginia Division of Corrections shall not photocopy or otherwise duplicate any materials containing any Aramark Proprietary Information without the prior written consent of Aramark. Upon the expiration or any termination of this Agreement, all manuals, software, computers, diskettes, disks and disk drives, and other materials or documents containing any Aramark Proprietary Information, shall be returned to Aramark.

#### DISCLAIMER OF INMATE LIABILITY

It is expressly understood that Aramark shall not be responsible for damages, injuries, losses or claims caused by offenders or the West Virginia Division of Corrections, its officers, employees, agents, servants or other independent contractors. Neither any of the West Virginia Division of Corrections's officers, employees, agents, servants or contractors, nor any offenders, are or will be deemed to be agents or employees of Aramark and no liability is or will be incurred by Aramark to such persons, except for bodily injury to such persons caused by Aramark's gross negligence.

#### BILLING AND INVOICING

Aramark Correctional Services will invoice West Virginia Division of Corrections at the end of each week/month. Invoiced commissary prices will be calculated on the prices included in this proposal.

#### INSURANCE

Aramark Correctional Services will provide the levels of insurance set forth in the specifications, except as provided in this Proposal. Aramark Correctional Services has provided a certificate(s) of insurance evidencing appropriate coverage.
