

Please know AssetWorks will not be responding to the solicitation detailed above. The State's requirements specify that a solution must be locally installed on the State's servers, and AssetWorks cannot comply with these requirements. The AssetWorks solution complies with the State's functional requirements and many of the State's technical requirements presented in the solicitation; however, the AssetWorks solution is offered in a Software as a Service, vendor hosted model which is used by 100% of our 16 current State and Federal surplus customers. AssetWorks has been utilizing this model for 15 years and has maintained an impeccable level of security for our customer's data. Our solution could save the State a significant amount of time, resources, and money because all necessary server hardware, software, maintenance, and upgrades are provided by AssetWorks.

By excluding this type of a solution, the State is cutting out the potential to receive bids from AssetWorks and any other vendor who may offer their solution in this fashion. The State was made aware of the fact that AssetWorks would not be able to respond to such a RFP long before the solicitation was created. Because of the stipulations contained within the request, AssetWorks asked the State to reconsider holding fast to the position that a SaaS solution is not acceptable. The State responded with a simple answer: No, we are not interested in considering a SaaS, vendor hosted solution. Please comply with the Specifications as written.

The limiting nature of this RFP will drastically reduce the State's number of responses, and the State is losing out on an opportunity to have a truly competitive bid process. Specifically, the State has excluded the company which has the largest market share of any software company for the management of State and Federal Surplus property, AssetWorks.
