



## PURCHASING AFFIDAVIT

MANDATE: Under W. Va. Code §SA-3-10a, no contract or renoval of any contract may be awarded by the state or any of its polatical subdivisions to any vender or prospective vender when the vender or prospective vender or a related party to the vender or prospective vender is a debier and: (1) the debt owed is an amount greater than one thousand delians in the appropriate; or (2) the debter is in employer default.

EXCEPTION: The prohibition listed above does not apply where a vendor has contested any too administered pursuant to chapter eleven of the W. Vo. Code, workers' compensation promiting, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

#### DEFINITIONS:

"Debt" means any assessment, premium, penalty, line, tax or other amount of money owed to the state or any of its publical subdivisions because of a judgment, fine, penalt violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accound thereon.

"Employer default" means having an outstanding balance or liability to the old fund or to the uninsured employers' fund or being in policy default, as defined in W. Va. Gode § 23-20-2, falking to maintain mandatory workers' compensation coverage, or feature to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the insurance Commissioner and remains in compilance with the obligations under the repayment agreement.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vender by blood, muriage, awnership or contract through which the party has a relationship of ownership or other interest with the vender so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vender contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

AFFIRMATION: By signing this form, the vendor's authorized signer elitims and acknowledges under penalty of law for false swearing (W. Vs. Code 561-53) that neither vendor nor any related party owe a debt as defined above and that neither vendor nor ony related party one in employer default as defined above, unless the debt or employer default is permitted under the exception above.
