- 1. Is a revision to LIQUIDATED DAMAGES for delivery timing possible?**
 - a. Liquidated Damages section will change to read - “.5% of the agency’s purchase requisition amount for delivery delays beyond 120 working days. This amount will be assessed daily. The liquidated damages only apply when the vendor doesn’t notify the agency to arrange shipping prior to the 120 days required.”

- 2. May we bid multiple vehicles for a single classification?**
 - a. Yes, please submit a separate bid pricing sheet for each vehicle being bid. The Vendor Name, Manufacturer/Brand and Model Name & Number section should be completed on each pricing page submitted.

- 3. FOR CLASS 6A, 6B, 6C. Does the 6 door requirement mean 1 LF, 1 RF, 2 rear facing, and 2 passenger side mid body?**
 - a. This requirement will be changed to a minimum of 5 doors for Classes 6A, 6B, and 6C. The 5 doors should include a minimum of – 1 Left Front, 1 Right Front, 1 passenger side mid body, and 2 rear facing.

- 4. FOR CLASS 6A, 6B, 6C, 7. Is a 4cylinder diesel acceptable?**
 - a. We will change the engine requirements for Classes 6A, 6B, 6C, and 7 to a minimum of 6 cylinders for gasoline engines and a minimum of 4 cylinders for diesel engines.

- 5. May an additional Class 6 full size van 10 passenger be added? If so, please classify with 1 driver, 1 RF passenger and 8 rear passenger OR 1 driver, 0 RF and 9 passenger rear.**
 - a. This class will not be added to this solicitation.

- 6. May a class 6 compact cargo van be added?**
 - a. This class will not be added to this solicitation.

- 7. FOR CLASS 17. Will a 13025 lb GVWR be acceptable? GM 13025 lb GVW unit has a hitch and 5th wheel trailer rating of 22423 lbs and a combined weight rating (GCWR) of 30500 lbs.**
 - a. The GVWR requirement for Class 17 will be reduced to 13,000 minimum. The Torque will be reduced to 765 minimum lbs.

- 8. I did check with my manufacturers and some pricing will not be available until October 15-20, 2016. Any help of a 1-3 week extension of bid opening would be helpful.**
 - a. Bid Opening will be extended from October 13, 2016 to October 25, 2016 at 1:30 PM, EST.

- 9. Class 6A, 6B, 6C & 7. Diesel Engine of minimum size of 4 cylinder from 5 cylinder.**
 - a. Please see question 4.

- 10. Class 17- 13025 GVWR or 765 ft/lb of torque from specs of 14000 GVWR and 900 ft/lb of torque.**
 - a. Please see question 7.

- 11. On the Class 7 Automobile cargo van. You do not want window in the van correct.**
 - a. Class 7 Cargo vans shall be delivered with window.

- 12. On the class 11 large pick up do you want a short bed or long bed?**
 - a. Bed Length provided should be the standard length for trucks meeting other mandatory specifications listed on the Class 11 pricing page.

- 13. Is trailer brake control considered part of the wiring on the truck?**
 - a. Yes, trailer brake control is part of the wiring on the truck.

- 14. Liquidated Damages - this provision is overly punitive to the vendor, given that the vendor cannot control the manufacturing or shipment of vehicles and typically do not stock the necessary vehicles to fill the orders.**
 - a. Please see question 1.

- 15. 3.1.1.1 - I. - Manufacturer's standard spare tire with jack- If a spare tire and jack are not standard equipment, is the vendor required to supply an optional spare tire and jack?**
 - a. This section will be changed to read "Manufacturer's standard spare tire with jack, when available as standard equipment."

- 16. 6.1 - As it relates to the 120 day and 60 day required delivery times, auto dealers do not control the manufacturing or shipment of vehicles, therefore, we cannot guarantee delivery times.**
 - a. The requirement for 120 day and 60 day delivery times will remain the same. The language in section 6.2 Late Delivery will change to read as follows:

"The Agency placing the order under this Contract must be notified in writing if order will be delayed. Vendor shall pay liquidated damages in the amount of 5% of the agency's purchase requisition amount for delivery delays beyond 120 working days. This amount will be assessed daily. The liquidated damages only apply when the vendor doesn't notify the agency to arrange shipping prior to the 120 days required"

- 17. 6.5 - As the vendor typically does not stock the necessary vehicles to fill the orders, requiring the vendor to accept a return due to no fault of their own could be overly burdensome as the vendor cannot return the product to the manufacturer. In the instance of a very large order to be returned due to an agency error, the vendor could ultimately be bankrupted by such an action.**

 - a. Section 6.5 will be removed from the specifications and no longer applies.

- 18. 8.2 - As noted above, the vendor typically does not stock the necessary vehicles to fill the orders.**

 - a. Section 8.2 will be removed from the specifications and no longer applies.

- 19. Class 12 & 15 - I would like to suggest that "front and rear" be removed from the requirement for tow hooks. Most vehicles that have tow hooks as standard or optional equipment do not have four tow hooks available and I believe it was agreed in the past by the interested agencies that need tow hooks, that they would not require both "front and rear tow hooks". Perhaps simply requiring "tow hooks" without identifying a location or number, such as is currently the case in class 16, would suffice.**

 - a. The requirement will change from "front and rear tow hooks" to "tow hooks."

- 20. Class 11, 12, 13A, 13B, 14, 15, 16 - If your intent is to keep the same minimum number of engine cylinders as you required in MV16, I would like to suggest that the pricing page indicate "gasoline engine - 8 cylinder minimum, Diesel engine - 6 cylinder minimum.**

 - a. For Class 11, 12, 13A, 13B, 14, 15, and 16 the engine requirement will change to a minimum of 8 cylinders for gasoline engines and a minimum of 6 cylinders for diesel engines.

- 21. Class 12 & 15 - Sliding rear windows seem to be needed in very few circumstances and could be added after the vehicle purchase in order to save money on those that are not needed.**

 - a. The requirement for rear sliding windows will be removed from Class 12 and 15.

- 22. Class 12, 15, 17 - Slush mats on a vinyl floor could be hazardous as they may slide under the driver's feet interfering with braking and acceleration. 3.1.1.1 M. Already states that floor mats are required except where vinyl floor covering is present. Since these trucks generally come with a vinyl floor, the specifications seem to contradict one another.**

 - a. This requirement will change to read "Slush/All weather Mats: Installed on driver and passenger front and second row, except where vinyl floor covering is present."

- 23. I would also request that the bid opening be moved to October 20, 2016.**

 - a. Please see question 8.

- 24. 3.1.1.7 Must the PO number be on the MSO??**

 - a. The PO number must be present on the invoice. Vendor should also put the PO number on the Statement of Origin or the Bill of Sale.

25. 3.1.1.4 F Window stickers are to be removed. Delivery personnel at Surplus property request that the window stickers be left in window of unit.

- a. This will be changed to read "Wash/Clean interior and exterior of vehicle. Remove all unnecessary tags, stickers (including window stickers), papers, tags etc. Window Stickers need to be removed from the window, but left in the vehicle."

Upon request, the Vendor must provide all necessary releases to obtain information to enable the Purchasing Division Director or the Agency to verify that the Vendor is licensed and in good standing with the above entities.

33. ANTITRUST: In submitting a bid to, signing a contract with, or accepting a Award Document from any agency of the State of West Virginia, the Vendor agrees to convey, sell, assign, or transfer to the State of West Virginia all rights, title, and interest in and to all causes of action it may now or hereafter acquire under the antitrust laws of the United States and the State of West Virginia for price fixing and/or unreasonable restraints of trade relating to the particular commodities or services purchased or acquired by the State of West Virginia. Such assignment shall be made and become effective at the time the purchasing agency tenders the initial payment to Vendor.

34. VENDOR CERTIFICATIONS: By signing its bid or entering into this Contract, Vendor certifies (1) that its bid or offer was made without prior understanding, agreement, or connection with any corporation, firm, limited liability company, partnership, person or entity submitting a bid or offer for the same material, supplies, equipment or services; (2) that its bid or offer is in all respects fair and without collusion or fraud; (3) that this Contract is accepted or entered into without any prior understanding, agreement, or connection to any other entity that could be considered a violation of law; and (4) that it has reviewed this Solicitation in its entirety; understands the requirements, terms and conditions, and other information contained herein.

Vendor's signature on its bid or offer also affirms that neither it nor its representatives have any interest, nor shall acquire any interest, direct or indirect, which would compromise the performance of its services hereunder. Any such interests shall be promptly presented in detail to the Agency. The individual signing this bid or offer on behalf of Vendor certifies that he or she is authorized by the Vendor to execute this bid or offer or any documents related thereto on Vendor's behalf; that he or she is authorized to bind the Vendor in a contractual relationship; and that, to the best of his or her knowledge, the Vendor has properly registered with any State agency that may require registration.

35. VENDOR RELATIONSHIP: The relationship of the Vendor to the State shall be that of an independent contractor and no principal-agent relationship or employer-employee relationship is contemplated or created by this Contract. The Vendor as an independent contractor is solely liable for the acts and omissions of its employees and agents. Vendor shall be responsible for selecting, supervising, and compensating any and all individuals employed pursuant to the terms of this Solicitation and resulting contract. Neither the Vendor, nor any employees or subcontractors of the Vendor, shall be deemed to be employees of the State for any purpose whatsoever. Vendor shall be exclusively responsible for payment of employees and contractors for all wages and salaries, taxes, withholding payments, penalties, fees, fringe benefits, professional liability insurance premiums, contributions to insurance and pension, or other deferred compensation plans, including but not limited to, Workers' Compensation and Social Security obligations, licensing fees, etc. and the filing of all necessary documents, forms, and returns pertinent to all of the foregoing.

Vendor shall hold harmless the State, and shall provide the State and Agency with a defense against any and all claims including, but not limited to, the foregoing payments, withholdings, contributions, taxes, Social Security taxes, and employer income tax returns.

36. INDEMNIFICATION: The Vendor agrees to indemnify, defend, and hold harmless the State and the Agency, their officers, and employees from and against: (1) Any claims or losses for services rendered by any subcontractor, person, or firm performing or supplying services, materials, or supplies in connection with the performance of the Contract; (2) Any claims or losses resulting to any person or entity injured or damaged by the Vendor, its officers, employees, or subcontractors by the publication, translation, reproduction, delivery, performance, use, or disposition of any data used under the Contract in a manner not authorized by the Contract, or by Federal or State statutes or regulations; and (3) Any failure of the Vendor, its officers, employees, or subcontractors to observe State and Federal laws including, but not limited to, labor and wage and hour laws.

37. PURCHASING AFFIDAVIT: In accordance with West Virginia Code § 5A-3-10a, all Vendors are required to sign, notarize, and submit the Purchasing Affidavit stating that neither the Vendor nor a related party owe a debt to the State in excess of \$1,000. The affidavit must be submitted prior to award, but should be submitted with the Vendor's bid. A copy of the Purchasing Affidavit is included herewith.

38. ADDITIONAL AGENCY AND LOCAL GOVERNMENT USE: This Contract may be utilized by other agencies, spending units, and political subdivisions of the State of West Virginia; county, municipal, and other local government bodies; and school districts ("Other Government Entities"). Any extension of this Contract to the aforementioned Other Government Entities must be on the same prices, terms, and conditions as those offered and agreed to in this Contract, provided that such extension is in compliance with the applicable laws, rules, and ordinances of the Other Government Entity. If the Vendor does not wish to extend the prices, terms, and conditions of its bid and subsequent contract to the Other Government Entities, the Vendor must clearly indicate such refusal in its bid. A refusal to extend this Contract to the Other Government Entities shall not impact or influence the award of this Contract in any manner.

39. CONFLICT OF INTEREST: Vendor, its officers or members or employees, shall not presently have or acquire an interest, direct or indirect, which would conflict with or compromise the performance of its obligations hereunder. Vendor shall periodically inquire of its officers, members and employees to ensure that a conflict of interest does not arise. Any conflict of interest discovered shall be promptly presented in detail to the Agency.

40. REPORTS: Vendor shall provide the Agency and/or the Purchasing Division with the following reports identified by a checked box below:

Such reports as the Agency and/or the Purchasing Division may request. Requested reports may include, but are not limited to, quantities purchased, agencies utilizing the contract, total contract expenditures by agency, etc.

Quarterly reports detailing the total quantity of purchases in units and dollars, along with a listing of purchases by agency. Quarterly reports should be delivered to the Purchasing Division via email at purchasing.requisitions@wv.gov.

41. BACKGROUND CHECK: In accordance with W. Va. Code § 15-2D-3, the Director of the Division of Protective Services shall require any service provider whose employees are regularly employed on the grounds or in the buildings of the Capitol complex or who have access to sensitive or critical information to submit to a fingerprint-based state and federal background inquiry through the state repository. The service provider is responsible for any costs associated with the fingerprint-based state and federal background inquiry.

After the contract for such services has been approved, but before any such employees are permitted to be on the grounds or in the buildings of the Capitol complex or have access to sensitive or critical information, the service provider shall submit a list of all persons who will be physically present and working at the Capitol complex to the Director of the Division of Protective Services for purposes of verifying compliance with this provision. The State reserves the right to prohibit a service provider's employees from accessing sensitive or critical information or to be present at the Capitol complex based upon results addressed from a criminal background check.

Service providers should contact the West Virginia Division of Protective Services by phone at (304) 558-9911 for more information.

42. PREFERENCE FOR USE OF DOMESTIC STEEL PRODUCTS: Except when authorized by the Director of the Purchasing Division pursuant to W. Va. Code § 5A-3-56, no contractor may use or supply steel products for a State Contract Project other than those steel products made in the United States. A contractor who uses steel products in violation of this section may be subject to civil penalties pursuant to W. Va. Code § 5A-3-56. As used in this section:

- a. "State Contract Project" means any erection or construction of, or any addition to, alteration of or other improvement to any building or structure, including, but not limited to, roads or highways, or the installation of any heating or cooling or ventilating plants or other equipment, or the supply of and materials for such projects, pursuant to a contract with the State of West Virginia for which bids were solicited on or after June 6, 2001.
- b. "Steel Products" means products rolled, formed, shaped, drawn, extruded, forged, cast, fabricated or otherwise similarly processed, or processed by a combination of two or more or such operations, from steel made by the open heath, basic oxygen, electric furnace, Bessemer or other steel making process. The Purchasing Division Director may, in writing, authorize the use of foreign steel products if:
- c. The cost for each contract item used does not exceed one tenth of one percent (.1%) of the total contract cost or two thousand five hundred dollars (\$2,500.00), whichever is greater. For the purposes of this section, the cost is the value of the steel product as delivered to the project;
- d. The Director of the Purchasing Division determines that specified steel materials are not produced in the United States in sufficient quantity or otherwise are not reasonably available to meet contract requirements.

43. PREFERENCE FOR USE OF DOMESTIC ALUMINUM, GLASS, AND STEEL: In Accordance with W. Va. Code § 5-19-1 et seq., and W. Va. CSR § 148-10-1 et seq., for every contract or subcontract, subject to the limitations contained herein, for the construction, reconstruction, alteration, repair, improvement or maintenance of public works or for the purchase of any item of machinery or equipment to be used at sites of public works, only domestic aluminum, glass or steel products shall be supplied unless the spending officer determines, in writing, after the receipt of offers or bids, (1) that the cost of domestic aluminum, glass or steel products is unreasonable or inconsistent with the public interest of the State of West Virginia, (2) that domestic aluminum, glass or steel products are not produced in sufficient quantities to meet the contract requirements, or (3) the available domestic aluminum, glass, or steel do not meet the contract specifications. This provision only applies to public works contracts awarded in an amount more than fifty thousand dollars (\$50,000) or public works contracts that require more than ten thousand pounds of steel products.

The cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than twenty percent (20%) of the bid or offered price for foreign made aluminum, glass, or steel products. If the domestic aluminum, glass or steel products to be supplied or produced in a "substantial labor surplus area", as defined by the United States Department of Labor, the cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than thirty percent (30%) of the bid or offered price for foreign made aluminum, glass, or steel products. This preference shall be applied to an item of machinery or equipment, as indicated above, when the item is a single unit of equipment or machinery manufactured primarily of aluminum, glass or steel, is part of a public works contract and has the sole purpose or of being a permanent part of a single public works project. This provision does not apply to equipment or machinery purchased by a spending unit for use by that spending unit and not as part of a single public works project.


All bids and offers including domestic aluminum, glass or steel products that exceed bid or offer prices including foreign aluminum, glass or steel products after application of the preferences provided in this provision may be reduced to a price equal to or lower than the lowest bid or offer price for foreign aluminum, glass or steel products plus the applicable preference. If the reduced bid or offer prices are made in writing and supersede the prior bid or offer prices, all bids or offers, including the reduced bid or offer prices, will be reevaluated in accordance with this rule.

1. **PURPOSE AND SCOPE:** The West Virginia Purchasing Division is soliciting bids on behalf of all state agencies and political subdivisions to establish an open-end contract for 2017, or latest model year, motor vehicles – Class 6-7 and Class 11-17.
2. **DEFINITIONS:** The terms listed below shall have the meanings assigned to them below. Additional definitions can be found in section 2 of the General Terms and Conditions.
 - 2.1 **“CNG/ Bi-fuel motor vehicle”** means a motor vehicle that is capable of operating on either an alternative - Certified Natural Gas or conventional fuel based on driver selection.
 - 2.2 **“Contract Item” or “Contract Items”** means the list of items identified in Section 3.1 below and on the Pricing Pages.

- 2.11 **“Pricing Pages”** means the schedule of prices, estimated order quantity, and totals contained in wvOASIS or attached hereto as Exhibit A, and used to evaluate the Solicitation responses.

- 2.13 **“Solicitation”** means the official notice of an opportunity to supply the State with goods or services that is published by the Purchasing Division.

3.1.1.2 Unspecified Accessories & Features: All parts, equipment, accessories, material, design and performance characteristics not specified herein, but which are necessary to provide a complete unit, must be furnished with each unit and required to conform to strength, quality of material, and quality of workmanship to those which are advertised and provided to the market in general by the unit industry. vendors that provide the Contract Items meeting the required specifications for the lowest unit price depending on class per fuel type vehicle class as shown on the Pricing Pages. Moreover, any vehicle below 8500 GVWR will be awarded based on total life cycle cost, while any vehicle above 8500 GVRW will be awarded based on lowest unit price. Additionally, vehicle class 6A, 6B, 6C, and 7 will be awarded based on lowest unit price.
