
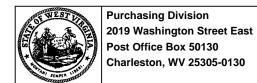



Vendor Questions and Responses

Question 1: In order to get all contractors bidding the same building; please consider adding the following to your addendum.

The buildings' design shall meet the standards of the 2015 International Building Code.

The contractor shall furnish the owner with detailed erection drawings of the building system stamped by a WV licensed engineer. The contractor shall furnish the owner a letter of certification from a WV licensed engineer that all design criteria has been met for the building system.

The contractor shall engage a WV licensed engineer to inspect the building upon completion and draft a letter to the owner that the building has been installed per cods and is ready to be occupied by the owner.

Answer 1: Yes, to all the above.

Question 2: Consider extending the June 30th completion date an additional 30 days. 21 calendar days is not enough time for this project.

Answer 2: The total number of days to complete this project will be changed from 21 to 60 calendar days after receipt of notice to proceed.

Question 3: Where is the overhead door located?

Answer 3: The roll up door will be placed on the gable end of the building on the east side.

Question 4: Are the roof overhangs on both the eaves and gables?

Answer 4: No overhangs are necessary for this building.

Question 5: Is there to be metal soffit and fascia on these roof overhangs?

Answer 5: There will be no soffit or fascia on this building.

Question 6: Is there gutter and downspouts on this building?

Answer 6: There will be no downspouts or gutter for this building.

Question 7: The size of the overhead door is noted in the project plans as 102x10'.

Please clarify.

Answer 7: After reviewing this, the rollup door shall be 120 inches high x 144 inches wide.

Question 8: What is the mesh size and gauge for the wire reinforcing in the concrete floor?

Answer 8: 6-inch X 6-inch pattern, 10guage wire.

Question 9: The location of the building was located on the existing asphalt at the prebid meeting. Should the asphalt be removed and necessary gravel installed and compacted to place the floor slab?

Answer 9: Yes, concrete shall be removed, but can used by the facility.

Question 10: The concrete slab by the spec's written in RFQ is 4". Should the thickest be 6" and 4,000 PSI Concrete? Should the concrete slab have a turn-down edge around the perimeter of 2 foot with 3 runs of 5/8" rebar around the perimeter for freeze/thraw? Should 6 x 6 reinforcement wire be placed in the slab with plastic vapor barrier under slab?

Answer 10: Yes

Question 11: The building size is 24' x 48' x 14' Post frame Construction, has to be engineered, drawn, and stamped by registered engineer with license in West Virginia. Could this post frame design be changed to a conventional building and still be designed by a registered engineer or architect to meet the same wall, ceiling, siding, and roof intent as the post frame building?

Answer 11: Yes, this can be a conventional building.

Question 12: No mention of treated wood on posts in spec's. Should all wood that comes into contact with earth, gravel or concrete be treated wood?

Answer 12: All wood that contacts the earth shall be treated wood.

Question 13: Should the roofing metal materials be standing seam with concealed fasteners?

Answer 13: The fasteners for the siding do not need to be concealed.

Question 14: Should aluminum soffit and fascia be install to weather and bug proof the building?

Answer 14: The building shall be weather and bug proof.

Question 15: Should aluminum continuous gutters and downspouts be installed?

Answer 15: See answer 6.

Question 16: Should windows be burglar proof?

<u>Answer 16:</u> The windows do not need to be burglar proof.




