Q1) Were there any other documents for the RFQ that had more details on the server specs?

A1) No

Q2) We would have to know the operating system type required, RAID level, Hard drive size, RAM size, etc. to provide a quote.

A2) We will install Windows 2016. We will be using multiple RAID configurations. RAID must be implemented in hardware, not software. Hard drive sizes and RAM sizes are specified in the RFQ.

Q3) For solicitation number (CRFQ-0708-ABC180000005-1) what type of network connectivity do you want?

A3) The servers must have four 1G Ethernet data ports and one management port.

Q4) Regarding RAID and OS installation:

For configuration 3.1.1.x, the system has 8x 600 GB SAS 12G 10K RPM SFF HS drives.

How should the RAID be configured across these drives? Will these be multiple RAID configurations, one for OS, and one for data, or one large volume? If one large volume, what size partition should be created for OS install?

A4) The agency will configure the drives and RAID settings.

Q5) For configurations 3.1.2.x, the system has 8x600GB SAS 12G 10K RPM SFF HS drives and 14x 12 TB SAS 12G 10K RPM SFF HS drives. How should the RAID be configured across these drives? Will there be multiple RAID configurations, one for OS, and one for data, or one large volume? If one large volume, what size partition should be created for OS install?

"Employer default" means having an outstanding balance or liability to the old fund or to the uninsured employers' fund or being in policy default, as defined in W. Va. Code § 23-2c-2, failure to maintain mandatory workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

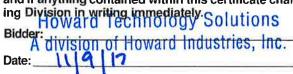
