The written specifications for this form only shows four paper line item descriptions (missing the last CF ply/sheet). A performance bond, proof of commercial general liability and Disclosure of Interested Parties to the Contract will be provided before the award of the contract per the written RFQ specifications.

Thank you for the opportunity to quote the Secure Paper Printing package for Solicitation No. CRFQ 0802 DMV1800000006.

When reviewing the specifications and pricing out the individual documents in the request for quotation we feel there is some conflicting information with the written specifications, the provided samples and addendum(s) with the initial RFQ. Therefore, we are going to submit two different bids based our assumptions of what you are trying to accomplish and be on a same playing field as the other bidders.

Our pricing for this bid takes into consideration the following assumptions which are not clearly outlined in the specifications and adjusted according the addendum answer.

- 1) Quantities for each line item is based on producing the specified quantities and shipping them to the Charleston destination based on the Addendum response. Addendum 3, answer to question 3 states different production and shipping quantities and frequency of the shipments which does not match the initial RFQ. The pricing of this quote reflects the adjusted production and shipment quantities based on the addendum question and response. The price is based on the addendum quantities, however the original quantities on the pricing pages and OASIS is still used for bid calculation purposes.
- 2) Line item 4, Sample D item Power of Attorney documents. The written 3.4.1 specifications for this document list a 5 part form and the line item description for each part only shows four paper parts of the form. Is the fifth part the solid carbon sheet between parts 1 and 2 or is the 5th ply left off the specification sheet (it would be a white 15lb. CF sheet which would then match the physical sample)? We are assuming the 5th ply of white 15lb. CF was left off the line item description on the specifications sheet and matched the provided sample. We are pricing based on 5 paper parts and one full carbon sheet.
- 3) Electronic layout and artwork files will be provided for each document and each part/ply of the document(s).
- 4) A performance bond, proof of commercial general liability and Disclosure of Interested Parties to Contract will be provided before the award of the contract per the RFQ specifications and terms.

Please let me know if you have any questions of need further information as we are here to assist and make your job and responsibilities easier.

PURCHASING AFFIDAVIT

CONSTRUCTION CONTRACTS: Under W. Va. Code § 5-22-1(i), the contracting public entity shall not award a construction contract to any bidder that is known to be in default on any monetary obligation owed to the state or a political subdivision of the state, including, but not limited to, obligations related to payroll taxes, property taxes, sales and use taxes, fire service fees, or other fines or fees.

ALL CONTRACTS: Under W. Va. Code §5A-3-10a, no contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and: (1) the debt owed is an amount greater than one thousand dollars in the aggregate; or (2) the debtor is in employer default.

EXCEPTION: The prohibition listed above does not apply where a vendor has contested any tax administered pursuant to chapter eleven of the W. Va. Code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Employer default" means having an outstanding balance or liability to the old fund or to the uninsured employers' fund or being in policy default, as defined in W. Va. Code § 23-2c-2, failure to maintain mandatory workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceeds five percent of the total contract amount.

AFFIRMATION: By signing this form, the vendor's authorized signer affirms and acknowledges under penalty of law for false swearing (W. Va. Code §61-5-3) that: (1) for construction contracts, the vendor is not in default on any monetary obligation owed to the state or a political subdivision of the state, and (2) for all other contracts, that neither vendor nor any related party owe a debt as defined above and that neither vendor nor any related party are in employer default as defined above, unless the debt or employer default is permitted under the exception above.

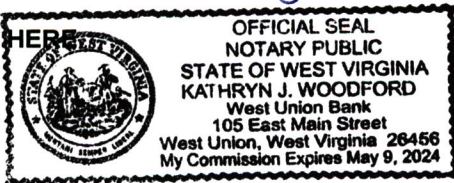

Bidder has been or expects to be approved prior to contract award by the Purchasing Division as a certified small, women- and minority-owned business.

Bidder understands if the Secretary of Revenue determines that a Bidder receiving preference has failed to continue to meet the requirements for such preference, the Secretary may order the Director of Purchasing to: (a) rescind the contract or purchase order; or (b) assess a penalty against such Bidder in an amount not to exceed 5% of the bid amount and that such penalty will be paid to the contracting agency or deducted from any unpaid balance on the contract or purchase order.

By submission of this certificate, Bidder agrees to disclose any reasonably requested information to the Purchasing Division and authorizes the Department of Revenue to disclose to the Director of Purchasing appropriate information verifying that Bidder has paid the required business taxes, provided that such information does not contain the amounts of taxes paid nor any other information deemed by the Tax Commissioner to be confidential.
