
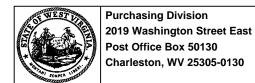

PROJECTS AND REFERENCES

Project: South Wheeling Historic District, Wheeling, West Virginia

The firm was contracted by Wheeling Heritage to prepare a National Register nomination for the South Wheeling Historic District. From its earliest days, South Wheeling was the site of major industries, and the area's development was directly related to its prominence as an industrial hub in the 19th and early 20th centuries. During that time, five major manufacturing industries in South Wheeling (glassware, nails, pottery/tile, beer, and tobacco) were producing products for regional, national and international markets. Immigrants, especially German and Irish, populated the area and worked in the plants, and housing was constructed to accommodate the factory workers and their families. Religious, civic and commercial buildings were also constructed to serve the population. South Wheeling also represents the physical manifestation of the deindustrialization of the American economy in general, and specifically, the economy of Wheeling and the Upper Ohio Valley. The District includes 216 contributing resources. The nomination was approved by the West Virginia Archives and History Commission in February 2019 and is pending with the National Park Service.

Project: Zoar Historic District National Register and National Historic Landmark Nominations, Zoar, Ohio

The Zoar Village Historic District National Register Nomination (1969, 1975) was amended to expand the district boundaries and to greatly enhance the description of contributing buildings and the explanation of the Village's historic significance. This project became the basis for a nomination of the District as a National Historic Landmark. This important work was undertaken by Heritage with Nathalie Wright, Historic Preservation Consultant, and was administered by the Ohio History Connection. This effort was prompted by the need to demonstrate the true historic significance of Zoar as the Army Corps of Engineers considered treatment options for an existing unsound levee that extends along the entire western and southern boundaries of the village and protects the community from flooding from the Tuscarawas River. One option that the Corps was considering was the removal of the levee, which would have threatened the future existence of the community. As a result, the Village, which was founded by German Separatists in 1817, was placed on the National Trust for Historic Preservation's listing of the 11 Most Endangered Historic Places. The Corps has since discarded the option of removing the levee. The District includes 70 contributing resources. The amended nomination was added to the National Register of Historic Places in September 2013 and was designated a National Historic Landmark in September 2016.

The firm was contracted by Downtown Xenia Now (DXN) to produce a National Register nomination for the Downtown Xenia Historic District. It was the intent of DXN to obtain National Register designation in order to facilitate both the recognition of the historic architectural fabric while enabling potential future economic development opportunities in the downtown district. Xenia was founded in 1803 as the county seat of the newlyformed Greene County. The district includes 46 contributing buildings and represents the civic and commercial development of an inland Ohio county seat from the early 19th century to the mid-20th century. The Downtown Xenia Historic District was added to the National Register of Historic Places in September 2014.
