
SureAdhere Mobile Technology, Inc. ("SureAdhere") is pleased to submit this proposal in response to the West Virginia Office of Epidemiology and Prevention Services, Division of Tuberculosis Elimination's request for Video DOT Services (Solicitation #CRFQ-EHP1900000001). SureAdhere is a company strategically focused on assisting Tuberculosis (TB) control programs to provide exceptional treatment monitoring and support to TB patients in a cost-efficient manner using mobile technology. We offer a turn-key, subscription-based Video Directly Observed Therapy (VDOT) service that was developed and evaluated through partnerships between academic researchers and public health agencies. Through these collaborations, SureAdhere's VDOT system is a highly effective treatment monitoring tool ideally suited for any size health department, as well as other providers who need to observe their patients ingesting other treatment regimens or performing observable health behaviors.

SureAdhere's roots date back to 2009, when co-founder Dr. Richard Garfein's team at the University of California San Diego, which included company CEO Dr. Kelly Collins, pioneered the use of *asynchronous* VDOT as a mobile technology tool for improving TB treatment monitoring. Dr. Garfein is an internationally recognized infectious disease epidemiologist and expert in the field of tuberculosis epidemiology, diagnostics and treatment adherence. SureAdhere currently provides VDOT services to a number of state and local health departments throughout the U.S. and continues to expand its client base both domestically and globally.

SureAdhere's VDOT platform includes a patient-facing mobile application (compatible with both iOS and Android operating systems), which patients use to make and upload daily (encrypted and date/time-stamped) videos of their medication ingestion. TB staff can then log into SureAdhere's cloud-hosted, HIPAA-compliant web portal to view videos and document observations regarding the patient's medication adherence. In this proposal, we discuss our VDOT platform functionalities in depth, and provide an explanation as to how our system meets or exceeds all VDOT system requirements specified in this solicitation.

SureAdhere is dedicated to serving public health departments as they work to cure TB, limit its transmission and prevent acquired drug resistance by using evidence-based, cost-effective, technology-driven strategies designed to improve medication adherence monitoring.

We appreciate your consideration of our proposal.

Section 3. Request for Quotation – Qualifications

Section 3.1. Experience providing asynchronous video DOT service

Since 2009, SureAdhere's co-founder (Dr. Garfein) and CEO (Dr. Collins) have worked to conceive, develop and evaluate an asynchronous VDOT application and its implantation worldwide. Their experience began prior to founding SureAdhere Mobile Technology, Inc. in 2014 and continues in both academic and commercial environments. They first developed VDOT in collaboration with the San Diego County Health and Human Services Agency, TB Control and Refugee Health Program, which has adopted VDOT as the standard-of-care for TB treatment adherence monitoring. The prototype VDOT app was initially developed and pilot tested in San Diego, California and Tijuana, Mexico with funding from the National Institutes for Health and found to be highly feasible, acceptable, and potentially improved adherence compared to in-person DOT (Garfein, et al., Int J Tuberc Lung Dis, 2015;19(9):1057-1064). The platform was subsequently evaluated in five California health departments, which showed that VDOT performed equally well in rural and urban health districts with high adherence and lower cost compared to DOT (Garfein, et al., Emerg Infect Dis, 2018;24(10):1807-1815). Dr. Garfein also led the effort by the California Department of Public Health and the California TB Controllers Association to produce best practice guidelines for the use of VDOT (http://ctca.org/filelibrary/CDPH_CTCA%20eDOT%20Guidelines%20-%20Cleared-%20081116.pdf).

As an internationally recognized expert in the field of TB epidemiology and treatment adherence, Dr. Garfein currently serves as a member of the World Health Organization's Global Task Force on Digital Health for Tuberculosis and is frequently invited to speak about VDOT at national and international conferences.

In 2014, SureAdhere Mobile Technology, Inc. ("SureAdhere") was founded to translate this research into practice. Since licensing the VDOT software from the University of California San Diego, SureAdhere substantially upgraded the VDOT platform based on experience obtained from prior research and feedback from existing clients. The platform was also subjected to third-party auditing to ensure that technical specifications and company policies meet or exceed patient privacy and data security standards specified in the Health Insurance Portability and Accountability Act (HIPAA).

SureAdhere's VDOT platform is currently in use by the New York City Department of Mental Health and Hygiene for monitoring TB treatment adherence, including patients enrolled in a CDC-funded randomized controlled trial of asynchronous and synchronous VDOT compared to DOT (<https://clinicaltrials.gov/ct2/show/NCT03266003?term=burzynski&recrs=a&rank=1>) that will inform national policy around VDOT use. In addition, Drs. Collins and Garfein have contributed to VDOT evaluations in seven U.S. cities, the United Kingdom, Vietnam and Uganda. Two recently funded studies will also evaluate SureAdhere's VDOT app for multi-drug resistant TB patients in the Philippines and prisoners in Haiti.

Section 3.2. Experience providing asynchronous video DOT service with other public health entities

Since June 2015, SureAdhere has provided VDOT service to over 5000 patients with drug susceptible, drug resistant, pulmonary and extrapulmonary TB, which included minors and non-English speakers. SureAdhere's app has also been used to monitor treatment of latent TB infection (LTBI) and suspected active TB. Currently, SureAdhere's clients include 24 TB programs in the U.S. and abroad and one substance abuse treatment program using VDOT for monitoring opioid substitution therapy. Given their experience serving clients with TB caseloads ranging from less than 10 (e.g., Napa County, CA, State of Missouri, State of Arkansas, etc.) to several hundred (e.g., New York City, NY, San Francisco, CA, etc.), SureAdhere is fully capable of providing service in the quantity specified in this Solicitation and can seamlessly scale up or down depending on the program's needs. Based on its well-documented experience with national, state and local health departments, SureAdhere is exceptionally positioned to deliver the highest quality, reliable, HIPAA-compliant VDOT solution.

In January 2016, SureAdhere contracted with a third-party auditor (Chan Health) to conduct a HIPAA security assessment of our system & software; a copy of our compliance letter will be made available upon request. SureAdhere conducts annual penetration testing of both our web portal and mobile applications, and quarterly vulnerability scans of all production IP's to ensure ongoing HIPAA and HITECH compliance.</p> <p>The next scheduled audit will be performed in November 2018.</p> <p>All protected health information (PHI), including patient videos, is encrypted through AES 256/RAS 2048-supported protocols during transmission and while stored on mobile devices and SureAdhere servers.</p> <p>All patient video and text messaging data are stored in an encrypted format, uploaded to a secure server that exceeds HIPAA compliance standards, and protected with username/pin log-in access credentials. 4.1.1.3 Asynchronous video DOT application must track observed and/or reported symptoms and medication side-effects	YES	The CMS contains fields for documenting medication side effects that are reported by the patient or observed by the treatment monitor. Patients may report side effects in their videos, by phone, or in person. Furthermore, the treatment monitor may observe signs while watching patient videos and document them in the CMS. When side effects are documented in the CMS, they are clearly displayed in the patient's daily treatment record, monthly calendar, and patient dashboard. In addition, the patient's case manager can receive email notifications whenever side effects are entered into the CMS.
4.1.1.4 Asynchronous video DOT application must provide a date and time stamp for all videos	YES	All videos are date- and time-stamped by the VDOT app before they are encrypted and uploaded to the CMS. To ensure fidelity, videos are stored in a manner that prevents patients from accessing them, so they cannot be altered, deleted, or sent more than once.
4.1.1.5 Asynchronous video DOT application must provide automatic patient reminders	YES	<p>Patient Medication Reminders and Alerts. Optional patient reminders can be sent via email or SMS message depending on patient preference. Text messages may also be sent to a phone number that is different from the device used to take daily videos, which gives patients more options to receive reminders in a manner that is most convenient and confidential for them. Additionally, patients are prompted to contact their provider in the event they are experiencing symptoms or side-effects <i>before</i> they can record a video using the application.</p> <p>Delinquent Video Notifications for Providers. TB Control staff have the option to set up alerts that notify the provider (i.e., the nurse or DOT worker) if a patient misses a dose or fails to upload a video to the system. For example, a nurse can set</p>

		his/her user account to receive email notifications once or twice per day that contain a list of his/her designated patients who have not uploaded a video by the scheduled medication time over the last 24 hours.

4.1.1.7 Asynchronous video DOT application must provide ability for a provider to initiate a HIPAA-secure live chat with patient.	Partial—Full Functionality Expected in 2 nd quarter 2019.	SureAdhere is in the process of incorporating a HIPAA compliant live chat application into our VDOT platform. We expect to have this functionality released by the second quarter 2019. However, while a live chat window cannot be directly opened in our application just yet, the SureAdhere case management system may still be used to observe and document patients ingesting medications via other HIPAA-secure, no-cost conferencing applications such as Skype for Business, Zoom, etc. Video conference observations can then be recorded as such to differentiate them from <i>asynchronous</i> video DOT and in-person DOT in the case management system.

YES	The CMS contains a 'Reports' tab from which providers may view, print and download reports for one or more patients, including all video sessions. Currently, the system supports the generation and exportation of both individual and aggregate medication adherence reports based on patient/staff manager lists. If the precise report of interest is not yet included in the CMS, SureAdhere will partner with Department/Agency to develop additional reports <u>at no additional cost</u> . Once SureAdhere engineers have programmed a report into the CMS, it can be generated on-demand by Department/Agency staff at any time.

YES	<p>The SureAdhere CMS allows users to visualize both patient and population specific analytics. For example, the CMS contains a “Dashboard” tab that displays adherence data by day, week, and month for groups of patients corresponding to one or more available filters. Additionally, the dashboard display is color-coded to allow users to quickly determine the status of individual patients or multiple patients.</p> <p>Additionally, in each patient’s profile, an “Overview” tab graphically displays the patient’s overall adherence, number of doses taken/missed, the method of observation used, and medication side effects reported/observed.</p>
4.1.1.11 Asynchronous video DOT application must support multiple dosing schedules (i.e. daily, split or intermittent).	YES	<p>SureAdhere’s CMS supports daily, split and intermittent dosing. In addition, the CMS will allow users to change the dosing frequency while tracking when doses were expected throughout the patient’s entire treatment history. Split dosing schedules created in the CMS are displayed as multiple doses for each day in the patient’s dose calendar.</p>
4.1.1.12 Vendor must offer daily unlimited use of the system.	YES	<p>The SureAdhere system is available 24/7 with no limits on the frequency or duration of use by patients or providers.</p>

Thus, no software or hardware installation by the Department/Agency is required. Code § 23-2c-2, failure to maintain mandatory workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceeds five percent of the total contract amount.

AFFIRMATION: By signing this form, the vendor's authorized signer affirms and acknowledges under penalty of law for false swearing (W. Va. 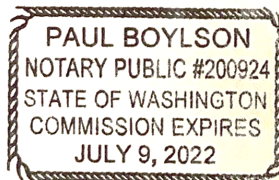
