



Thrasher designed and inspected a utility project for Camp Dawson, which included a potable water supply from the City of Kingwood, sanitary sewer service from Camp Dawson to the City of Kingwood, and a natural gas supply line to the Army National Guard Center on the Kingwood side of the Cheat River along Route 72.

This project included all three supply lines crossing the Cheat River in the same general trench. Conduits were a 10" water line, 6" sanitary force main, and a 3" HDPE natural gas supply line.

This project consisted of the design and construction of a 500,000 GPD wastewater treatment plant to serve the Northpointe Business and Industrial Park and Hazelton Prison. Additionally, a standard gravity sanitary sewer extension was designed and constructed to serve 30 additional customers and 3 businesses.

Once this wastewater treatment plant was operating, the firm was hired to design a supplemental sanitary sewer line extension that now serves an additional 85 new customers.

Also, Thrasher partnered with the Preston County Public Service District and approached the DEP to secure debt forgiveness for the proposed Glade Sanitary Sewer System Extension project. Thrasher explored options for construction of a collection system with an independent wastewater treatment plant in the area of Glade Meadows Subdivision

The City of Bridgeport has been experiencing numerous problems with storm water runoff within the Compton Park Watershed. Thrasher has evaluated the watershed as a whole, focusing on the areas around Meadow Lane, Glen Avenue, and the crossings between James Street and the watershed's main tributary. These areas were analyzed with the typical storm events as well as with a theoretical storm event that replicated a three (3) inch rainfall within a 60 minute duration (the latter is an imitation of the type of storm that is causing the majority of problems within the City).

Based on the analysis herein, Thrasher determined that the greatest impact to this watershed could be obtained by implementing the following improvements:

- Installation of a new outlet structure within the existing pond at the base of "Compton Farm"
- Construction of a flood wall along the main drainage channel immediately upstream of the crossing with James Street
- Installation of a new storm sewer collection system upstream of and through Meadow Lane
- Installation of a new storm sewer collection system upstream of and through Glen Avenue

Thrasher was retained for turnkey master planning, engineering, and construction management services for the preeminent mixed use business park in northcentral West Virginia. White Oaks is located along Interstate 79 in the rapidly developing Bridgeport area.

The development focus of White Oaks is providing hospitality, office, and visitors services to the adjacent major hospital complex and the Federal Bureau of Investigation National Biometrics Center which is located nearby.

As a first step, Thrasher worked with a partner firm in preparing a detailed market analysis to determine the most economically beneficial mix of land uses. This analysis produced a summary of recommended land use categories, estimates supportable square footage amounts and projected market absorption rates. This information was used to develop several concept land use plans that explored different land use, transportation and open space configurations.

Additional market data was prepared leading to the selection of the preferred White Oaks Business Park Master Plan. Thrasher provided all engineering, cost estimating, bidding services, construction management and materials testing services during the construction phase. The Thrasher team also developed the covenant and restriction guidelines for the development. The covenants and restrictions established site and building design specifications including materials, scale, massing and orientation.
