Client Objective

WV CPRB has requested two developers to maintain and enhance its Compass system.

Deliverables

Skypunch can provide an AWS Certified Solution Architect to work onsite for some yet-to-be-determined number of hours. This individual may serve in the role of solution architect/business analyst and as a relay to developers located elsewhere. Given that the consultants usually assigned jobs by Skypunch are already booked, we will need to call upon additional help which the extremely compressed timeline between receiving responses to RFQ questions and the deadline for submitting the proposal (three working days) simply does not allow for.

It is worth pointing out that Skypunch Technology is not a staffing agency, we are a consulting firm. While we understand there is an immediate interest in just finding someone who can keep Compass operational, our long-term interest is in helping to ensure the application complies with the *5 Pillars of the AWS Well-Architected Framework* which would require more than three days to identify the right people to handle. We certainly recognize that the ask for this request was to provide responses direct from developers, so should that disqualify Skypunch from further consideration, we would hope to be engaged from the outset on any future projects so that we may help get them properly architected from the beginning to deliver business value and permit scaling as needs evolve.
