Deliverables

It is understood that WV PEIA seeks a database administrator. In reviewing the job description however, it becomes apparent that database administration is but one of multiple skills requested and satisfying those skills adequately requires multiple personnel. Skypunch can certainly provide a database administrator but we also have unsurpassed expertise with ColdFusion given that one of the founders has been a full-stack ColdFusion developer for 20 years, and as stated in the intro, another developer founded the company that literally wrote the manuals for ColdFusion in its early days. Finally, Skypunch has technical writing experience given that key personnel have years of experience as trainers and writing the documentation that goes along with that as well as user manuals for products and processes.

While Skypunch can certainly provide a DBA, we believe that providing an appropriately-skilled specialist for the differing requirements in the description means the highest level of expertise will be used for each of those requirements while also keeping the total number of consultant hours within the 2080 limit.

Costs

As discussed in the Deliverables section above, providing proper support for the different requirements means having more than one consultant with differing skills. Different skills come at different market rates which could result in a total bill for services provided differing based on which skills PEIA requests during the terms of the engagement.
