



The West Virginia Purchasing Division is soliciting bids on behalf of the WV Department of Administration, General Services Division ("Agency" and "Owner") to establish a contract for selective demolition of clay tile units followed by installation of new clay tile, concrete masonry units, or drywall assemblies in areas where existing clay tile is damaged or has been removed in the WV State Main Capitol Building. Some spaces also require structural stabilization of existing wall assemblies or installation of fire separation walls. Any space that requires remediation that is readily accessible to building occupants will be repaired in a manner that maintains the historical nature of the building. Spaces that are only accessible to maintenance staff will use more modern building materials and techniques to remediate the spaces per the attached specifications, terms and conditions and project plans.

1. CONTRACTOR'S LICENSE: West Virginia Code § 21-11-2 requires that all persons desiring to perform contracting work in this state be licensed. The West Virginia Contractors Licensing Board is empowered to issue the contractor's license. Applications for a contractor's license may be made by contacting the West Virginia Division of Labor. West Virginia Code § 21-11-11 requires any prospective Vendor to include the contractor's license number on its bid. If an apparent low bidder fails to submit a license number in accordance with this section, the Purchasing Division will promptly request by telephone and electronic mail that the low bidder and the second low bidder provide the license number within one business day of the request. 
