Responses to Questions for CRFQ: WWV2000000006-Drug Screening and Testing

Question

1. I was reading over the request for a quote and it looks like you want a 10 panel (section 3.1.1.7), but at the end of the document you have a DOT chain of custody form attached (Exhibit F). Do you want a quote for a 10 panel, DOT, or both? Or are you requiring the collection sites collect the 10 panel with the same procedures as a DOT test? There is a price difference between DOT and Non-Dot testing.

Response

1. Requesting quote for 10 panel, non-DOT, only.
A chain-of-custody process that is DOT/NIDA compliant is necessary as stated in 1.1.1.19-Vendor must ensure complete integrity of each specimen tested and respective test results by fully documenting the receiving, transfer, and handling of all specimens by laboratory personnel using the chain-of-custody documentation compliant with DOT/NIDA (Exhibit F).

Question

2. In reference to 3.1.1.6, would Workforce accept an internet based ordering service that would generate a DTA and allow case workers to set expiration dates and times?

Response

2. No.

Question

3. In reference to 3.1.1.12, would Workforce be willing to set a yearly cap for how many tests the vendor would cover for any B specimen tests?

Response

3. No. In the past, we experienced less than three each year.

Question

4. In reference to 3.1.1.13, if an internet based service can provide each Workforce location with results for that specific location, would Workforce consider removing sections 3.1.1.13 and 3.1.1.14? This same internet based service would also allow the vendor to give access to all of the results to anyone Workforce would identify as needing to have access.

Response

4. The chosen vendor must have an internet based service as stated in the RFQ to be accessed by designated WFWV employees-

3.1.1.13 Vendor will inform the participant of drug screen results via United States Postal Service within forty-eight (48) hours after collection of specimen for Negative tests. For positive results, the participant shall be informed within forty-eight (48) hours after review of the results by the Medical Review Officer.

3.1.1.14 Vendor shall ensure that all test results are clearly marked as Pass or Fail.

3.1.1.15 Vendor shall maintain an internet-based database of the test results. At a minimum, this database should include client name, address, last four digits of client's social security number, and the test results.

We do not wish to remove the sections from the RFQ.
