
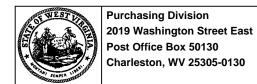

PURCHASING AFFIDAVIT

CONSTRUCTION CONTRACTS: Under W. Va. Code § 5-22-1(i), the contracting public entity shall not award a construction contract to any bidder that is known to be in default on any monetary obligation owed to the state or a political subdivision of the state, including, but not limited to, obligations related to payroll taxes, property taxes, sales and use taxes, fire service fees, or other fines or fees.

ALL CONTRACTS: Under W. Va. Code §5A-3-10a, no contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and: (1) the debt owed is an amount greater than one thousand dollars in the aggregate; or (2) the debtor is in employer default.

EXCEPTION: The prchibition listed above does not apply where a vendor has contested any tax administered pursuant to chapter eleven of the W. Va. "Employer default" means having an outstanding balance or liability to the old fund or to the uninsured employers' fund or being in policy default, as defined in W. Va. Code § 23-2c-2, failure to maintain mandatory workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

INTRODUCTION

Health Research Systems, Inc. (HRS) is pleased to submit this proposal to the West Virginia Department of Health and Human Resources (WV DHHR), Office of Drug Control Policy (ODCP) (hereinafter referred to as WV DHHR) for **CRFQ 0506 HHR200000005** Drug and Alcohol Testing Services.

At HRS we are keenly aware of the requirement for the WV DHHR to have a highly qualified provider that can ensure the delivery of all the required services in a timely and cost-effective manner. At HRS we have in place:

A corporate structure to support such a program

Quality personnel to effectively perform all levels of service

Rigorous training programs to ensure high level performance

An excellent quality assurance / control program to monitor the work performed

Software with reporting capabilities to summarize all activity of the testing program at any time

Internet / Intranet based reporting which enables HRS, the Laboratory and the Medical Review Officer (MRO) to transmit test information efficiently, safely, and securely.

Health Research Systems, Inc. (HRS) is a privately held corporation based in Huntington, WV with offices in Huntington, WV and Columbus, Ohio. HRS has expert personnel as well as the experience necessary to coordinate a program as intricate as that of WV DHHR.

SPECIFICATIONS

- **3.1** Health Research Systems has provided drug and alcohol testing services for over 27 years. All collectors are certified as required by Title 49 CFR Part 40.
- **4.1.1** HRS can begin services within 14-28 days of award.
- **4.1.2** HRS will provide all forms, collection kits and any miscellaneous supplies for the collections, transportation and analyses of urine specimens.
- **4.1.3** HRS will comply with all applicable medical standards; federal, state, and local government safety codes, laws and regulations relating to drug and alcohol testing.
- **4.1.4** HRS collects all specimens to meet the requirements of 49 CFR Part 40 with respect to conducting workplace drug and alcohol testing, for collecting and storing urine specimens, testing for drugs and alcohol, and ensuring confidentiality. HRS can offer mobile services or utilize a large network of off-site collection facilities.
- **4.1.6** HRS can provide scheduled services Monday through Friday, between 8:00 am EST and 5:00 pm EST, excluding West Virginia State Holidays.
- **4.1.7** HRS can be on site and ready to conduct testing within two (2) hours of the request for testing if a mobile collection is required.
- **4.1.8** HRS and all network collection facilities are strictly trained in compliance with 49 CFR Part 40.
- **4.1.9** HRS can have a network collection facility in every county of WV.
- **4.1.9.1** HRS understands that we are responsible for the satisfactory completion of the work.
- **4.1.9.2** HRS subcontractor will comply with all mandatory specifications of this RFQ.
- **4.1.9.3** HRS will receive payments in accordance to this solicitation.
- **4.1.9.4** HRS will make arrangements for the initial screening appointment to be observed by collection site personnel as long as the State of West Virginia understands that this can take up to 2 days to arrange.
- **4.1.10** HRS will provide a list of collection site that are accessible for residents if awarded the bid as we believe this information to be proprietary.
- **4.1.11** HRS will provide a list of subcontractors being utilized for the services contained in this solicitation if awarded the contract. Again HRS feels that this information is proprietary.
- **4.1.12** HRS will provide for transportation for all specimens to the testing laboratory in accordance with 49 CFR Part 40.

- **4.1.13** HRS will provide for testing of urine compliance with 49 CFR Part 40.
- **4.1.14** HRS only utilizes SAMHSA certified laboratories.
- **4.1.15** HRS will perform chemical analyses of urine specimens to determine whether the person from who the specimen was taken has been using any of the drugs listed in this solicitation.
- **4.1.16** HRS will provide a Certified Medical Review Officer (MRO) for this solicitation.
- **4.1.17** HRS will provide confirmed test results, of both negative results and positive test results for nonprescription drugs are made available, in writing, to Transition Agents or his/her designee via confidential means, immediately upon confirmation by the MRO, but not later than 72 hours after receipt of the specimen by the laboratory.
- **4.1.18** HRS ensures that all laboratory records are maintained for the appropriate period of time to comply with 49 CFR Part 40.
- **4.1.19** HRS will provide an account manager to be available Monday-Friday 8am-5pm for questions and to resolve problems.
- **4.1.20** HRS will provide a written recapitulation of the testing program on a monthly basis and provide by US mail a comprehensive listing within ten (10) calendar days to each respective thirty (30) Community Service Managers.

Specimen Collection, Laboratory, and Results Reporting

Breath alcohol testing and urine collection for drug screening requires trained, professional Breath Alcohol Technicians (BATs) and collectors. Lending leadership and support to the BAT/Collectors are corporate management personnel who are fully knowledgeable of Federal requirements and have attained a level of expertise in developing and administering complex programs.

This type of highly qualified support is necessary for programs such as that of the WV DHHR due to the need for:

Complete accuracy in testing procedures and documentation.

Total confidentiality in handling of all relevant data.

Collectors and breath alcohol technicians with well-developed interpersonal skills, capable of displaying sensitivity with client's employees.

HRS will provide a SAMHSA certified laboratory. The split sample method of collection, handling and storage will be utilized as well as other USDOT collection protocols unless otherwise specified by WV DHHR. All specimens are initially screened for the presence of the above drug metabolites utilizing immunoassay technology. All positive screens are automatically confirmed using gas chromatography / mass spectrometry (GC/MS) at no additional fees. Split specimen positive screens will be forwarded for testing at a different SAMHSA approved laboratory upon an employee's request. Drug tests will be reported to WV DHHR according to the specifications detailed in the RFQ.

The laboratory performs any required specimen adulteration assays necessary at no extra charge.

Rejected Specimens

If the client or laboratory reports troubled and/or rejected specimens these reports are sent to the Operations Manager. Upon receipt of this information several measures are taken to correct the error with the collector and to coordinate a second specimen being collected. In addition if troubled specimens can be salvaged by affidavit it is secured as soon as possible and forwarded to the appropriate entity (lab, MRO, client). After the immediate intervention has occurred the collector will be referred for retraining if needed. The rejected specimens will not result in fees to WV DHHR.

All specimens are initially screened for the presence of the above drug metabolites utilizing immunoassay technology. All positive screens are automatically confirmed using gas chromatography / mass spectrometry (GC/MS) at no additional fees. Split specimen positive screens will be forwarded for testing at a different SAMHSA approved laboratory upon an employee's request. The laboratory performs any required specimen adulteration assays necessary at no extra charge.

The laboratory retains custody of any positive urine specimen under properly secured refrigerated conditions in accordance with established governmental regulations (at the least a minimum of one year). Any urine specimen which does not test positive upon confirmation is destroyed in accordance with governmental regulations.

All laboratory-positive results will be downloaded to Dr. Kracht for review. In the event of a laboratory positive the MRO will perform a telephonic interview with the donor to determine any "legitimate" causes (prescription medication, food sources, etc.). If necessary, the donor may be requested to provide proof of prescription, or medical records. The MRO may find it necessary to speak with the donor's pharmacy or physician to verify prescription information and or medical history. Dr. Kracht adheres to strict rules of confidentiality.
