

SPECIFICATIONS

- 1. **PURPOSE AND SCOPE:** The West Virginia Division of Administrative Services is soliciting bids on behalf of the State Fire Commission to establish an open-end contract for Truck Toppers, Bed Slides, Truck Tonneau Covers, and Installation.
- 2. **DEFINITIONS:** The terms listed below shall have the meanings assigned to them below. Additional definitions can be found in section 2 of the General Terms and Conditions.
 - **2.1** "Contract Item" or "Contract Items" means the list of items identified in Section 3.1 below and on the Pricing Pages.
 - 2.2 "Pricing Pages" means the schedule of prices, estimated order quantity, and totals contained in wvOASIS or attached hereto as Exhibit A, and used to evaluate the Solicitation responses.
 - **2.3 "Solicitation"** means the official notice of an opportunity to supply the State with goods or services.
 - 2.4 "Agency" means The State Fire Commission/West Virginia Fire Marshall

3. GENERAL REQUIREMENTS:

- 3.1 Contract Items and Mandatory Requirements: Vendor shall provide Agency with the Contract Items listed below on an open-end and continuing basis. Contract Items must meet or exceed the mandatory requirements as shown below.
 - 3.1.1 2019 FORD F-250 TRUCK TOPPER- A.R.E. DCU MAX (or equal) ALUMINUM
 - 3.1.1.1 2019 Ford F-250 Truck Topper and fit the 8' and the 6'9" truck bed and be flush not having a gap and be the full length of the bed.
 - 3.1.1.2 2019 Ford F-250 Truck Topper must be a minimum 26" in height and must not exceed 30" in height.

- 3.1.1.3 2019 Ford F-250 Truck Topper exterior must be painted to match vehicle, with paint code UX- Ingot Silver (per the manufacturer).
- 3.1.1.4 2019 Ford F-250 Truck Topper must have full length rear door that is hatchback w/no window.
- 3.1.1.5 2019 Ford F-250 Truck Topper must have full length rear door that is hatchback must have locks and all must be keyed alike.
- 3.1.1.6 2019 Ford F-250 Truck Topper must not have a front window.
- **3.1.1.7** 2019 Ford F-250 Truck Topper must have standard toolboxes with double doors on both sides.
- 3.1.1.8 2019 Ford F-250 Truck Topper must have #9 shelving on driver's side and #2 shelving on the passenger side. Shelves must be made of aluminum and extend the internal length of the topper fully. See Exhibit B.
- 3.1.1.9 2019 Ford F-250 Truck Topper must match the truck shelving diagram in Exhibit B. Measurements are based on the 8' and 6'9" topper being bid.
- **3.1.1.10** 2019 Ford F-250 Truck Topper must not have roof or side racks attached to the topper.

3.1.2 2019 Ford F-250 fitted Truck Bed Slide- A.R.E CARGOGLIDE 2200XL (or equal)

- **3.1.2.1** 2019 Ford F-250 fitted Truck Bed Slides must be capable of supporting 2200 lbs. maximum
- **3.1.2.2** 2019 Ford F-250 fitted Truck Bed Slide must be installed by vendor and fit the 8'and the 6'9" truck bed.

3.1.3 2019 Ford F-250 Truck Tonneau Cover-Diamond Back HD or equal

- 3.1.3.1 Tonneau Cover must fit an 8'or 6'9" truck bed.
- **3.1.3.2** Tonneau Cover must be constructed of a minimum .100" 3003 alloy aluminum and cannot exceed .200" 3003 alloy.
- **3.1.3.3** Truck Tonneau Cover must have two panels for bed access on the front and rear of the cover.
- **3.1.3.4** Truck Tonneau Cover must have locks on both panels and the locks, must be keyed alike.
- **3.1.3.5** Truck Tonneau Cover must have a Factory Installed black spray-on finish.
- **3.1.3.6** Truck Tonneau Cover must have a minimum 3/8" or stronger deadbolt style, steel lock rods.
- **3.1.3.7** Truck Tonneau Cover must have neoprene gasket covers on all four sides.
- **3.1.3.8** Truck Tonneau Cover must include a water-resistant seal around the edges.
- **3.1.3.9** Truck Tonneau Cover must be installed by the vendor not a third party.
- 3.1.3.10 Truck Tonneau Cover must support a maximum of 1,600 pounds.
- 3.1.3.11 Truck Tonneau Cover must be no drill installation.
 - **3.1.3.12** Truck Tonneau Cover must include a minimum of 12 tie down cleats but must not exceed 14.

3.1.3.13 Truck Tonneau Cover exterior must have stainless steel exterior hardware

3.1.4 Installation

- 3.1.4.1 Vendors must bid an all-inclusive lump sum hourly rate for the installation of the equipment that is indicated on the Pricing Page Exhibit A. Failure to bid installation will result in disqualification.
- 3.1.4.2 Vendor must protect installed products until completion of project.
- 3.1.4.3 Vendor Must provide Manufacturer's Data sheets on each product being used.
- **3.1.4.4** Vendor Must provide proper preparation instructions and maintenance recommendations.
- 3.1.4.5 Vendor must inspect equipment for damages prior to acceptance. If damage is found, follow freight handler's procedure claims.
- **3.1.4.6** Vendor is responsible for furnishing all materials necessary to complete the installation.

4. CONTRACT AWARD:

- 4.1 Contract Award: The Contract is intended to provide the Agency with a purchase price on all Contract Items. The Contract shall be awarded to the Vendor that provides the Contract Items meeting the required specifications for the lowest overall total cost as shown on the Pricing Pages.
- 4.2 Pricing Pages: Vendor should complete the Pricing Pages by entering the unit price for each item. Vendor should complete the Pricing Pages in their entirety as failure to do so may result in Vendor's bids being disqualified.

5. ORDERING AND PAYMENT:

- 5.1 Ordering: Vendor shall accept orders through wvOASIS, regular mail, facsimile, email, or any other written form of communication. Vendor may, but is not required to, accept on-line orders through a secure internet ordering portal/website. If Vendor has the ability to accept on-line orders, it should include in its response a brief description of how Agencies may utilize the on-line ordering system. Vendor shall ensure that its on-line ordering system is properly secured prior to processing Agency orders on-line.
- 5.2 Payment: Vendor shall accept payment in accordance with the payment procedures of the State of West Virginia.

6. DELIVERY AND RETURN:

- 6.1 Delivery Time: Vendor shall deliver standard orders within Forty (40) working days after orders are received. Vendor shall deliver emergency orders within Twenty (20) working day(s) after orders are received. Vendor shall ship all orders in accordance with the above schedule and shall not hold orders until a minimum delivery quantity is met.
- 6.2 Late Delivery: The Agency placing the order under this Contract must be notified in writing if orders will be delayed for any reason. Any delay in delivery that could cause harm to an Agency will be grounds for cancellation of the delayed order, and/or obtaining the items ordered from a third party.
- 6.3 Delivery Payment/Risk of Loss: Standard order delivery shall be F.O.B. destination to the Agency's location. Vendor shall include the cost of standard order delivery charges in its bid pricing/discount and is not permitted to charge the Agency separately for such delivery. The Agency will pay delivery charges on all emergency orders provided that Vendor invoices those delivery costs as a separate charge with the original freight bill attached to the invoice.

- 6.4 Return of Unacceptable Items: If the Agency deems the Contract Items to be unacceptable, the Contract Items shall be returned to Vendor at Vendor's expense and with no restocking charge. Vendor shall either make arrangements for the return within five (5) days of being notified that items are unacceptable or permit the Agency to arrange for the return and reimburse Agency for delivery expenses. If the original packaging cannot be utilized for the return, Vendor will supply the Agency with appropriate return packaging upon request. All returns of unacceptable items shall be F.O.B. the Agency's location. The returned product shall either be replaced, or the Agency shall receive a full credit or refund for the purchase price, at the Agency's discretion.
- 6.5 Return Due to Agency Error: Items ordered in error by the Agency will be returned for credit within 30 days of receipt, F.O.B. Vendor's location. Vendor shall not charge a restocking fee if returned products are in a resalable condition. Items shall be deemed to be in a resalable condition if they are unused and in the original packaging. Any restocking fee for items not in a resalable condition shall be the lower of the Vendor's customary restocking fee or 5% of the total invoiced value of the returned items.

7. VENDOR DEFAULT:

- 7.1 The following shall be considered a vendor default under this Contract.
 - 7.1.1 Failure to provide Contract Items in accordance with the requirements contained herein.
 - 7.1.2 Failure to comply with other specifications and requirements contained herein.
 - 7.1.3 Failure to comply with any laws, rules, and ordinances applicable to the Contract Items provided under this Contract.
 - 7.1.4 Failure to remedy deficient performance upon request.
- 7.2 The following remedies shall be available to Agency upon default.
 - 7.2.1 Immediate cancellation of the Contract.
 - 7.2.2 Immediate cancellation of one or more release orders issued under this Contract.

7.2.3 Any other remedies available in law or equity.

8. MISCELLANEOUS:

- **8.1** No Substitutions: Vendor shall supply only Contract Items submitted in response to the Solicitation unless a contract modification is approved in accordance with the provisions contained in this Contract.
- **8.2** Vendor Supply: Vendor must carry sufficient inventory of the Contract Items being offered to fulfill its obligations under this Contract. By signing its bid, Vendor certifies that it can supply the Contract Items contained in its bid response.
- **8.3** Reports: Vendor shall provide quarterly reports and annual summaries to the Agency showing the Agency's items purchased, quantities of items purchased, and total dollar value of the items purchased. Vendor shall also provide reports, upon request, showing the items purchased during the term of this Contract, the quantity purchased for each of those items, and the total value of purchases for each of those items. Failure to supply such reports may be grounds for cancellation of this Contract.
- 8.4 Contract Manager: During its performance of this Contract, Vendor must designate and maintain a primary contract manager responsible for overseeing Vendor's responsibilities under this Contract. The Contract manager must be available during normal business hours to address any customer service or other issues related to this Contract. Vendor should list its Contract manager and his or her contact information below.
