
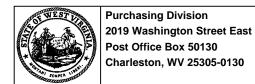

Question 1:

1. Regarding the 9" x 3" Plank:

CONTECH Produces this item in 9" nominal widths only. To get 18" widths & 27" widths, CONTECH proposes we shop weld our 9" planks together. This weld would be per AISI Handbook regarding joining adjacent planks. Is this acceptable?

Per AISI Handbook: Joining adjacent plates would be by... 1/8" x 1" fillet weld @ 24" centers @ top side of plank @ overlapping edges.

Answer 1:

The reason those lay widths were chosen is because other fabricators make them standard. Yes, that would be acceptable if they came shop welded.

Question 2:

- 1. Regarding the 12 x 4-1/4 Plank:
- o CONTECH Produces this item in 12" nominal widths only. To get 24" widths & 36" widths, CONTECH proposes we shop weld our 12" planks together. This weld would be per AISI Handbook regarding joining adjacent planks. Is this acceptable?
- o Per AISI Handbook: Joining adjacent plates would be by... 1/8" x 1" fillet weld @ 24" centers @ top side of plank @ overlapping edges.

Answer 2:

The reason those lay widths were chosen is because other fabricators make them standard. Yes, that would be acceptable if they came shop welded.

Question 3:

1. The contract states for each item that the net stringer spacings shall be minimum dimensions. We have maximum dimensions of 42" spacing for 9x3 and 60" spacing for 12x4.25" with HL-93 loading. The wording also says to meet or exceed HL-93 loading; however, we would need to deal with the "or exceed" projects on a case-by-case basis. Can you please confirm if the stringer spacings described in the contract are maximum dimensions or if our maximum spacing meets the requirements listed therein?

Answer 3:

The idea in our language was to make sure we didn't end up with an undersized deck plank. Yes, the vendor's maximum dimensions meet the requirements listed.
