
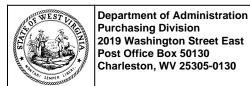

NAPA Auto Parts appreciates the opportunity to submit the following response to your CRFQ0212 SWC 2100000016 for Motor Vehicle Parts for the State of West Virginia. Our network of independent, West Virginia-based small business NAPA store owners and company owned NAPA stores jointly have worked on this proposal for the State to bring the best value and service to State of WV fleet operations and any municipal agencies that wish to join on the contract as a participating entity.

Upon review of the requirements and conditions outlined in the request for quotation, we are submitting the attached pricing quotation based on the expectations of the feet operations we work with in the State and our experience in the service needs of these agencies. We are following the known applicable regulations and/or requirements. We also understand that the discount percentage listed in our response will not change over the terms of the agreement and – per the terms will need to present any changes to the State at the annual contract renewal periods. We have reviewed and agree with the mandatory sections of the proposed contract put forth in the RFQ. Upon review of the documents, we do have minor suggestions for the State to consider in the case that our stores would be considered for an award. They are for your consideration only and are based on our experience with other State contract terms and are items that may limit the State from deriving specific benefits of such contracts with parts suppliers Statewide. We are prepared to discuss these clarifications during your evaluation process if you would like. Thank you for your consideration in this matter.

General Terms and Conditions, Section 41 General Terms and Conditions, Section 42: We often see these sections in general terms and conditions within RFPs and RFQs. Often the US made steel requirements are prevalent in construction contracts but difficult to track in general auto parts contracts. For example, these sections explicitly say that the goods sold in the contract must be made with US made steel. Virtually all vendors that supply auto parts will struggle to provide the State of WV documentation on where the steel that makes up their auto parts is sourced. Most of these parts are manufactured outside the US as well. For example, most all US auto parts chains sell brake rotors that are virtually 100% made with metal sourced outside the US. Likewise, nearly every vendor participating this RFQ does not manufacture products they will be supplying as part of this quote. We currently sell these products to all other states in the US and have obtained a waiver for this type of clause. We respectfully request the State Director of Purchasing consider a waiver on these two sections for this RFQ as it may preclude any vendor awarded from selling brake rotors to a State customer because the metal that makes them is almost assuredly made outside the US.

General Terms and Conditions, Section 44: Please consider adding 'or commodities remanufactured to OEM standards' after 'unused commodities. Many components require a core product to produce efficiently such as basic fleet starters or alternators and contain all new parts, but the shell may be a re-manufactured core product at a significant discount. We offer both new and remanufactured products that meet OE standards and specifications and would like to consider offering both types to the public. We currently sell remanufactured quality auto parts in every state contract in the US. This section could preclude a State agency from buying a remanufactured product that will fit the specs of a specific job at a significant savings to the State. We respectfully request the State Director of Procurement to consider this in a contract award final document.

- 1. REVIEW DOCUMENTS THOROUGHLY: The attached documents contain a solicitation for bids. Please read these instructions and all documents attached in their entirety. These instructions provide critical information about requirements that if overlooked could lead to disqualification of a Vendor's bid. All bids must be submitted in accordance with the provisions contained in these instructions and the Solicitation. Failure to do so may result in disqualification of Vendor's bid.
- **2. MANDATORY TERMS:** The Solicitation may contain mandatory provisions identified by the use of the words "must," "will," and "shall." Failure to comply with a mandatory term in the Solicitation will result in bid disqualification.

3. PREBID MEETING: The item identified below shall apply to this Solicitation.
A pre-bid meeting will not be held prior to bid opening

All Vendors submitting a bid must attend the mandatory pre-bid meeting. Failure to attend the mandatory pre-bid meeting shall result in disqualification of the Vendor's bid. No one individual is permitted to represent more than one vendor at the pre-bid meeting. Any individual that does attempt to represent two or more vendors will be required to select one vendor to which the individual's attendance will be attributed. The vendors not selected will be deemed to have not attended the pre-bid meeting unless another individual attended on their behalf.

An attendance sheet provided at the pre-bid meeting shall serve as the official document verifying attendance. Any person attending the pre-bid meeting on behalf of a Vendor must list on the attendance sheet his or her name and the name of the Vendor he or she is representing.

- **12. ACCEPTANCE:** Vendor's signature on its bid, or on the certification and signature page, constitutes an offer to the State that cannot be unilaterally withdrawn, signifies that the product or service proposed by vendor meets the mandatory requirements contained in the Solicitation for that product or service, unless otherwise indicated, and signifies acceptance of the terms and conditions contained in the Solicitation unless otherwise indicated.
- 13. PRICING: The pricing set forth herein is firm for the life of the Contract, unless specified elsewhere within this Solicitation/Contract by the State. Any waiver must be expressly stated in writing and signed by the waiving party.

- **28.** WARRANTY: The Vendor expressly warrants that the goods and/or services covered by this Contract will: (a) conform to the specifications, drawings, samples, or other description furnished or specified by the Agency; (b) be merchantable and fit for the purpose intended; and (c) be free from defect in material and workmanship.
- **29. STATE EMPLOYEES:** State employees are not permitted to utilize this Contract for personal use and the Vendor is prohibited from permitting or facilitating the same.
- **30. PRIVACY, SECURITY, AND CONFIDENTIALITY:** The Vendor agrees that it will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the Agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the Agency's policies, procedures, and rules. Vendor further agrees to comply with the Confidentiality Policies and Information Security Accountability Requirements, set forth in http://www.state.wv.us/admin/purchase/privacy/default.html.

35. VENDOR RELATIONSHIP: The relationship of the Vendor to the State shall be that of an independent contractor and no principal-agent relationship or employer-employee relationship is contemplated or created by this Contract. The Vendor as an independent contractor is solely liable for the acts and omissions of its employees and agents. Vendor shall be responsible for selecting, supervising, and compensating any and all individuals employed pursuant to the terms of this Solicitation and resulting contract. - **42. PREFERENCE FOR USE OF DOMESTIC ALUMINUM, GLASS, AND STEEL:** In Accordance with W. Va. Code § 5-19-1 et seq., and W. Va. If the domestic aluminum, glass or steel products to be supplied or produced in a "substantial labor surplus area", as defined by the United States Department of Labor, the cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than thirty percent (30%) of the bid or offered price for foreign made aluminum, glass, or steel products. This preference shall be applied to an item of machinery or equipment, as indicated above, when the item is a single unit of equipment or machinery manufactured primarily of aluminum, glass or steel, is part of a public works contract and has the sole purpose or of being a permanent part of a single public works project. This provision does not apply to equipment or machinery purchased by a spending unit for use by that spending unit and not as part of a single public works project.

Vendor shall provide the Purchasing Division with access to its internet ordering portal/website, if one will be used under this Contract, to allow the Purchasing Division to ensure that the requirements of this Contract are being met.

Agency Responsibilities:

A. Prior to Order:

Agencies must reconcile the list price, found in the vendors catalog, to the agreed contract discount price, (Example: If a solenoid has a list price of \$100.00, and the discount percentage is 5%, the price to the agency would be \$95.00. The cost to the Agency is found by multiplying the list price (\$100.00) by the discount percentage (.05) and subtracting from the list price (\$100.00). This tabulation may be handwritten but must be included.

B. Ordering Procedure:

Agencies should issue an Agency Delivery Order (ADO) to the Vendor for commodities covered under this contract. The spending unit should indicate on the face of the ADO if paying with a P-Card. Also, the Agency should state on the ADO if the items are for Pick-up or Delivery. The ADO should be provided to the vendor as authorization for shipment; a copy shall be retained by spending unit.

Orders shall be placed directly with vendor in a manner prescribed by the Agency, and not directly with the parts manufacturer. Pricing must be verified in accordance with the above prior to each order. Additionally, invoices must match the ADO and multiple items should be listed separately.

C. Pick-up orders:

For pick up orders only; Vendors should provide a list of available pick-up locations on Exhibit B List of Authorized Locations. The List of Authorized Locations must be received prior to award.

6.2 Invoicing and Payment: Vendor shall indicate the discount received on each invoice submitted for payment. Vendor shall accept payment in accordance with the payment procedures of the State of West Virginia. Methods of acceptable payment must include the West Virginia Purchasing Card. Payment in advance is not permitted under this Contract.

7. DELIVERY AND RETURN:

- **7.1 Delivery Time and Place:** Vendor shall deliver standard orders within three (3) calendar days after orders are received via vendor travel or freight carrier. Vendor shall deliver emergency orders within one (1) calendar day after orders are received. Vendor shall ship or deliver by common carrier or vendor's fleet delivery, all orders in accordance with the above schedule and shall not hold orders until a minimum delivery quantity is met. Eligible Items must be delivered to any location within the State of West Virginia.
- **7.2 Late Delivery:** The Agency placing the order under this Contract <u>must be notified in writing if orders will be delayed for any reason</u>. Any delay in delivery that could cause harm to an Agency will be grounds for cancellation of the delayed order, and/or obtaining the items ordered from a third party. Any agency seeking to obtain items from a third party under this provision must first obtain approval of the Purchasing Division.

- 7.3 Delivery Payment/Risk of Loss: Standard order delivery shall be F.O.B. destination to the Agency's location. Vendor shall include the cost of standard order delivery charges in its bid pricing/discount and is not permitted to charge the Agency separately for such delivery. The Agency will pay delivery charges on all emergency orders provided that Vendor invoices those delivery costs as a separate charge with the original freight bill attached to the invoice.
- 7.4 Return of Unacceptable Items: Items that Agency deems unacceptable shall be returned to Vendor at Vendor's expense and with no restocking charge. Vendor shall either make arrangements for the return within five (5) days of being notified that items are unacceptable, or permit the Agency to arrange for the return and reimburse Agency for delivery expenses. If the original packaging cannot be utilized for the return, Vendor will supply the Agency with appropriate return packaging upon request. All returns of unacceptable items shall be F.O.B. the Agency's location. The returned product shall either be replaced, or the Agency shall receive a full credit or refund for the purchase price, at the Agency's discretion.
- 7.5 Return Due to Agency Error: Items ordered in error by the Agency will be returned for credit within 30 days of receipt, F.O.B. Vendor's location. Vendor shall not charge a restocking fee if returned products are in a resalable condition. Items shall be deemed to be in a resalable condition if they are unused and in the original packaging. Any restocking fee for items not in a resalable condition shall be the lower of the Vendor's customary restocking fee or 5% of the total invoiced value of the returned items.
- **8. REPORTS:** The Vendor(s) shall quarterly utilization reports containing at a minimum the following information pertaining to the State of West Virginia agencies, boards, commissions, and political subdivisions:
 - **8.1** Ordering Entity;
 - **8.2** Purchase order number;
 - **8.3** Description;
 - **8.4** Quantity;
 - **8.5** Price.

 - **9.1.3** Failure to comply with any laws, rules, and ordinances applicable to the Contract Services provided under this Contract.
 - **9.1.4** Failure to remedy deficient performance upon request.
- **9.2** The following remedies shall be available to Agency upon default.
 - **9.2.1** Immediate cancellation of the Contract.
 - **9.2.2** Immediate cancellation of one or more release orders issued under this Contract.
 - **9.2.3** Any other remedies available in law or equity.

10. MISCELLANEOUS:


