

GRC Software Tool

- Our team would like to request an extension to the GRC Software Solution solicitation. With our team being remote and only a week between questions and the due date, our team does not have a sufficient amount of time to craft a comprehensive response.
 - A: We can extend 1 week.
- 2. In Requirements Section 4.1.1.4 -please explain how you define ranks and rates?
 - A: Ranks and rates are about measuring risk. As an example, when evaluating a specific security control, if there is an identified risk, that risk should be classified as high, medium, or low (ranks/ratings). Additionally, once all risks have been identified, those risks can be ranked to easily identify/order which are the more critical risks that need attention first.
- 3. In Requirements Section 4.1.1.5 please explain how you define opportunities?
 - A: When the GRC solution is identifying risk, there should be a way to document "opportunities" to address that risk, including whether the risk can be marked as being accepted, avoided, transferred, or mitigated. Additionally, there should be a method to document the outcome of how the risk was handled.
- 4. Have you seen solution demonstrations to you in preparation for this RFQ? If so, which solutions from which vendors?
 - A: No.
- 5. In the requirements section of the RFQ, the footer reflects a revision date of 12/12/2017. Was there a pervious procurement done for a similar solution? If so what was the result of that procurement? If it was cancelled, please explain why. If there was a 2017 procurement process, please share which vendors responded and with what solutions.
 - A: The 12/12/2017 revised date is the date the Purchasing Division revised our standard boilerplate for specifications and has nothing to do with the product being procured. The agency was required to use that form to solicit bids. This is the first time this solicitation has been released for public bid.
- 6. Are these requirements from 2017? If not, please explain the footer referencing a revision date of 12-12-2017.

Please see question 5 answer.

7. How many users are needed? LogicGate bases the pricing of users and how many use cases you may need.

A: Per 4.1.2.11 Vendor must provide at least fifteen (15) power user licenses and must be included in the lump sum cost on the Exhibit A Pricing Page Contract Item #1: Governance, Risk, and Compliance (GRC) Software Solution, Training and Support.

8. Can you clarify what these descriptions are asking for in the quote (mainly "customization" and "training"... what does 200 customizations mean to you?)

A: At first, customization and training refer to the initial implementation of the product. In the first year, it is expected that there will need to be implementation services to incorporate the work performed around the state's cyber security program and risk assessment methodology Additionally, initial training will be needed to train users how to use the product.

In future years, customization and training refers to the opportunity to engage professional services for additional implementation services and training as other agencies onboard into the GRC tool.

Per the pricing page, 200 represents the number of hours for these services. The pricing page is looking for the hourly rate as the Unit Cost, and then the total cost for 200 times the hourly rate for the Extended Cost.

9. What are the requirements for WV?

A: Please see Section 4 of the RFQ which details the Mandatory Requirements.

10. Are you looking for a SaaS(cloud software) or on-premise?

A: Per 4.1.1.1, the State is looking for a SaaS - Cloud Based Solution

11. Does the vendor have to be FedRAMP?

A: No, the vendor does not need to be FedRAMP certified.

12. What cloud certifications are mandatory in a vendor?

A: The only mandatory requirements for certifications are listed in 3.2 of the RFQ. The vendor's data center and/or cloud provider should have both SOC 2 Type 2 and ISO 27001 certifications.

13. What do "Units of Measure" mean?

A: From the pricing sheet, LS stands for Lump Sum and HR stands for Hourly.
