

We propose to provide all material, labor, equipment, and insurances necessary in accordance with the following scope of work:

#### **General Requirements**

- 1. Sales tax is included.
- 2. Temporary facilities, utilities i.e. water, heat and electric to be by others.
- 3. This quote is based on a 1st shift basis, Monday-Friday. Overtime and/or shift work is excluded.
- 4. Our proposal is based on entering into a contract based on the terms and conditions of the AIA 401 and is valid for a period of 30 days.
- 5. For any material which the manufacturer requires a deposit before manufacture or shipping, the deposit must be paid by the customer as a condition of Kalkreuth's material procurement for that material. Any specified manufacturer's payment terms of less than Net 30 will need to be invoiced and paid in accordance with their terms.
- 6. If Factory Mutual (FM) insures this project, they must approve the plans and specifications. If FM makes any changes, additional costs shall be the sole responsibility of the owner.
- 7. Roof protection from any other trades and rehabilitation of completed roofing is excluded.
- 8. Excludes allowances and disadvantaged business participation.
- 9. Performance and Payment bond is included.

- > Supply and install new 6" retro drains at existing drain openings.
- > Flash and counter flash all areas as necessary to provide a weather tight system.

## PURCHASING AFFIDAVIT

CONSTRUCTION CONTRACTS: Under W. Va. Code § 5-22-1(i), the contracting public entity shall not award a construction contract to any bidder that is known to be in default on any monetary obligation owed to the state or a political subdivision of the state, including, but not limited to, obligations related to payroll taxes, property taxes, sales and use taxes, fire service fees, or other fines or fees.

ALL CONTRACTS: Under W. Va. Code §5A-3-10a, no contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and: (1) the debt owed is an amount greater than one thousand dollars in the aggregate; or (2) the debtor is in employer default.

EXCEPTION: The prohibition listed above does not apply where a vendor has contested any tax administered pursuant to chapter eleven of the W. Va. "Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Employer default" means having an outstanding balance or liability to the old fund or to the uninsured employers' fund or being in policy default, as defined in W. Va. Code § 23-2c-2, failure to maintain mandatory workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

AFFIRMATION: By signing this form, the vendor's authorized signer affirms and acknowledges under penalty of law for false swearing (W. Va.
