STANDARD WARRANTY

General

Products: AGILAIRE warrants that all Equipment and Products furnished pursuant to an AGILAIRE sales order will be of the kind and quality described in Agilaire's proposal included herein. To repair or replace the defective product covered by this warranty at AGILAIRE is the sole and exclusive remedy under this warranty.

Services: AGILAIRE warrants that it will perform the service work under this contract in a thorough and workman-like manner, consistent with industry norms.

Warranty Period

Products: AGILAIRE warrants that all such products, except the items listed in the Exclusions below, when following AGILAIRE Operation and Maintenance Procedures for the Equipment and Products provided, will be free from defects in material and workmanship for a time period equal to the lesser of (i) twelve (12) months after completion of Equipment Start-up at the customer specified location or (ii) eighteen (18) months after delivery of the Equipment (the "Warranty Period") to customer specified location. Warranty for ESC products (e.g., Model 8832) are ninty (90) days from delivery.

Services: AGILAIRE will work to resolve any problems associated with the work that are identified and submitted to AGILAIRE within 60 days of the services provided.

Exclusions

- 1. **Unauthorized Repairs/Modifications:** AGILAIRE shall be released from all obligations under this warranty in the event repairs or modification are made by persons other than its own authorized service personnel, or service personnel from an authorized representative, unless such repair is minor, merely the installation of a new plug-in component.
- 1. Warranty Limitations: This warranty is limited to original products supplied by AGILAIRE, and shall not be construed to apply to the simultaneous and/or interdependent operation of this equipment with devices (hardware and/or software) supplied by others. This warranty does not apply to damage caused by ordinary wear and tear, nor does it apply to damage caused by misuse, abuse, vandalism, acts of God, or improper handling, storage, operation, or maintenance of the product.
- 2. Spare Parts: Spare parts are warranted for ninety (90) days after shipment.

Warranty Procedure

- 1. If within the Warranty Period, AGILAIRE receives written or confirmed e-mail notice promptly after the discovery of any nonconformance to the above warranties; AGILAIRE shall correct each such defect, at its option, either by repairing or replacing any defective part(s).
- 1. The initial reporting of a potential warranty defect by the customer will be made by the customer contacting AGILAIRE Customer Service. Agilaire's customer service representative will assess the defect dAgilaireribed by the customer and recommend further troubleshooting to isolate and determine the exact cause of the non-conformance.
- 2. If the defect can be corrected by telephone consultation with Agilaire's customer service representative, and no parts are required to correct the reported defect, then no further action will be taken by AGILAIRE.
- If the source of the defect can be determined by telephone consultation with Agilaire's customer service representative, and parts are required to correct the reported defect, AGILAIRE will ship the necessary parts to the customer to correct this defect. Agilaire's will assign a return authorization number for the defective parts to be returned to AGILAIRE, shipping prepaid by the customer.
- 4. If the customer elects to ship the defective part or product to AGILAIRE to correct the reported defect, AGILAIRE will assign a return authorization number for the defective parts/products to be returned to AGILAIRE, shipping prepaid by the customer. Upon receipt of the material, AGILAIRE will inform the customer of Agilaire's decision to repair or replace the defective part and the expected shipment date. AGILAIRE will prepay the return shipping charges.
- 5. As an option to returning the defective part/product to AGILAIRE, the customer may select the option of AGILAIRE to travel to site to make the warranty determination and repair the defective product on site. In this case, AGILAIRE will require a purchase order to be issued to cover travel expenses, travel time, and related expenses incurred by AGILAIRE personnel. <u>On site labor is provided at "No Charge" to the customer</u>. This purchase order shall be based on AGILAIRE Field Service Rates.
- 6. If during the evaluation of the warranty defect, it was determined that the cause of the product failure was due to improper maintenance or other customer related causes, AGILAIRE will request a purchase order to be issued or amended to cover the parts and labor (in-house or on-site) for the repair of the product.

Liability

The liability of AGILAIRE to Buyer arising out of the foregoing, whether under warranty, tort, contract, negligence, strict liability or otherwise, shall not in any case exceed the cost of correcting defects in the Equipment or Work and upon the expiration of said warranty, all such liability shall terminate.
