

PURCHASING AFFIDAVIT

CONSTRUCTION CONTRACTS: Under W. Va. Code § 5-22-1(i), the contracting public entity shall not award a construction contract to any bidder that is known to be in default on any monetary obligation owed to the state or a political subdivision of the state, including, but not limited to, obligations related to payroll taxes, property taxes, sales and use taxes, fire service fees, or other fines or fees.

ALL CONTRACTS: Under W. Va. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.



ROADQUAKE TPRS APPLICATIONS:

In December, 2008, we introduced our first commercially viable RoadQuake Temporary Portable Rumble Strip (RQ TPRS) traffic safety countermeasure.







FHWA LETTERS:

In March, 2007, the Federal Highway Administration (FHWA), issued PSS Acceptance Letter CC-97 for CrashGard® Sand Barrel System. CC-97 acknowledges that CrashGard passed NCHRP-350 Crash Tests. The letter confirms that CrashGard meets the criteria of NCHRP-350 Test Level 3 for non-redirective, gating crash cushions.

In March 2009, FHWA issued CC-97-A, an amendment to the original letter. The amendment accepts the use of CrashGard in "mixed array" configurations.

AASHTO Manual for Assessing Safety Hardware (MASH), test requirements supersede NCHRP-350 test requirements. Crash cushions are required to comply with MASH test guidelines by December 31, 2018.

FHWA issued Eligibility Letter CC-145 for CrashGard in September 2018. In CC-145 FHWA agrees CrashGard meets MASH test and evaluation requirements. CC-145 also states FHWA finds CrashGard eligible "for reimbursement under the Federal-Aid Highway Program."






