Increase 1st and 2nd vertical compartment curbside approximately 24" with deck plate base, swivel-n-lock hose hook

Compartment vented and bottle holding arrangement and incorporate vertical overlapping doors (2) additional slotted shelves in streetside 1st and 2nd compartment for a total of (3) shelves each

Relocate shelf from streetside rear compartment to curbside rear compartment and add (1) additional shelf for a total of (3)

Incorporate (1) rectangular light hole punched in each rear body panel

Install Straight side panel assembly 60" high on top of service body

Modify panel assembly over high tank compartments on curbside

Furnish and install a tire carrier on front bulkhead with recessed floor well inside floor area
