


- 1. As a dedicated partner to the West Virginia Office of Technology (WVOT), Peraton submits the following response to the Request for Quote, CRFQ 0210 ISC2400000004, dated 2023-08-17.
- Peraton has partnered with ScienceLogic and Voss-Solutions to offer VOSS Netflow Analytics
 Package Netflow monitoring software as an annual subscription to West Virginia Office of
 Technology. VOSS Netflow Analytics meets all the mandatory requirements in section 3 of the
 CRFQ as detailed below.
- 3. Software Requirements per the CRFQ:
 - 3.1.1. Software Requirements from CRFQ
 - 3.1.1.1. The Software must Integrate with version 11.2 or greater of ScienceLogic SL1 via a SL1 Powerpack.

The proposed solution meets this requirement by integrating with SL1 versions 11.x or greater via ScienceLogic Workflow Automation powerpack.

3.1.1.2. The Software must be capable of sending events and alerts to ScienceLogic SL1.

The proposed solution meets this requirement by deploying event policies via the ScienceLogic Workflow Automation powerpack.

3.1.1.3. The Software must allow the creation of custom events and alerts.

The proposed solution meets this requirement. This can be accomplished by leveraging SL1 delivered capabilities to customize and extend standard Netflow events and alerts into SL1.

3.1.1.4. The Software must provide full API coverage across all included components for extending integration into SL1 and/or other solutions as required.

The proposed solution meets this requirement with available APIs.

3.1.1.5. The Software must integrate with Science Logic 1 out of the Box as a PowerPack.

The proposed solution meets this requirement with an existing deployment PowerPack already developed.

3.1.1.6. The software must provide for up to 50,000 flows per second, with the ability to scale up to 200K flows per second.

The proposed solution meets or exceeds this requirement by providing 50,000 to 100,000 flows per second if deployed on required hardware platform to support this capacity. Solution



capacity can be scaled up to and through 200,000 flows per second with additional upgrade licensing and hardware to support.

3.1.1.7. The Software must allow the creation of custom events and alerts based on severity levels.

The proposed solution meets this requirement since ScienceLogic SL1 can be leveraged to configure custom events based on desired criteria monitored by the Voss Netflow software. A severity nomenclature can be created using this capability.

3.1.1.8. The Software must run a virtual machine on WVOT's existing VMWare infrastructure that runs the graphical user interface.

The proposed solution meets this requirement and can be deployed on WVOT's VMWare environment.

3.1.1.9. The software must have the ability to run on either a bare metal server or preferably a virtual machine on WVOT's existing VMWare infrastructure for receiving netflows from the devices.

The proposed solution meets this requirement. The software may be deployed on either a bare metal server or on WVOT's existing VMWare infrastructure.

3.1.1.10. The Software must support all versions of Netflow.

The proposed solution meets this requirement.

3.1.1.11. The Software must be multi-tenant capable.

The proposed solution meets this requirement and allows for each tenant to deploy a unique version of the user interface.

3.1.1.12. The Software must support a customizable user interface.

The proposed solution meets this requirement.

3.1.1.13. The Software must provide customer defined data retention policies.

The proposed solution meets this requirement.

3.1.1.14. The software must support SAML and LDAP integration.

The proposed solution meets this requirement.



3.1.1.15. The software must include Customizable reporting in the following formats - XLS/XLSX, JSON, PDF and CSV.

The proposed solution meets this requirement.

3.1.1.16. The software must have role based access control.

The proposed solution meets this requirement.

3.1.1.17. The software must support generating reports showing top talkers and top applications both inbound and outbound.

The proposed solution meets this requirement.

- 3.1.2. Professional Services
- 3.1.2.1. Vendor must install and configure the dashboard virtual machine and the collector server, and must configure the integration into SL1.

The proposed solution meets this requirement. The solution contains deployment services which will accomplish this requirement.

- 3.1.2.2. Vendor must provide training and documentation on the tool at both the end user and administrator level.
- 3.1.2.2.1. End user training is needed for 15 users.

The proposed solution meets this requirement. The training is WebEx-based, scheduled and trainer-delivered. The training is recordable which may be used to access for additional users for refresher or first-time training.

3.1.2.2.2. Administrator training is needed for 7 users.

The proposed solution meets this requirement. The training is WebEx-based, scheduled and trainer-delivered. The training is recordable which may be used to access for additional users for refresher or first-time training.

3.1.2.2.3. Training must cover how to utilize the software and allow for a live question and answer session. Virtual or in-person training is acceptable.

The proposed solution meets this requirement. The training is WebEx-based, virtual and interactive. Training will utilize the client's platform and therefore allow opportunity for questions and answer throughout.



3.1.2.2.4. Training must be successfully completed prior to payment for solution.

Peraton acknowledges that payment for the solution will be made upon successful completion of training.

3.1.3. Vendor must provide 24×7×365 support via toll-free telephone number for the duration of the contract. Support must also include patches, version updates, and bug fixes. Cost of support must be included in the software cost.

The proposed solution provides 24x7x365 support per the requirement. The licensing entitles WVOT to patches, version updates and bug fixes. Cost of support is included in the subscription license.

3.1.4. Vendor must provide pricing for Optional Annual Renewal Years 2, 3, and 4. Renewals will be initiated by the Agency, agreed to by the Vendor, and executed via Change Order issued by the Purchasing Division.

Peraton has provided pricing for the Optional Annual Renewal Years 2, 3, and 4. Peraton acknowledges WVOT's process to initiate and execute the subsequent award periods via Change Order issued by the West Viriginia Purchasing Division.

- 1. REVIEW DOCUMENTS THOROUGHLY: The attached documents contain a solicitation for bids. Please read these instructions and all documents attached in their entirety. These instructions provide critical information about requirements that if overlooked could lead to disqualification of a Vendor's bid. All bids must be submitted in accordance with the provisions contained in these instructions and the Solicitation. Failure to do so may result in disqualification of Vendor's bid.
- 2. MANDATORY TERMS: The Solicitation may contain mandatory provisions identified by the use of the words "must," "will," and "shall." Failure to comply with a mandatory term in the Solicitation will result in bid disqualification.

3. PREBID MEETING: The item identified below shall apply to this Solicitation.

All Vendors submitting a bid must attend the mandatory pre-bid meeting. Failure to attend the mandatory pre-bid meeting shall result in disqualification of the Vendor's bid. Vendor shall be responsible for selecting, supervising, and compensating any and all individuals employed pursuant to the terms of this Solicitation and resulting contract. Neither the Vendor, nor any employees or subcontractors of the Vendor, shall be deemed to be employees of the State for any purpose whatsoever. Vendor shall be exclusively responsible for payment of employees and contractors for all wages and salaries, taxes, withholding payments, penalties, fees, fringe benefits, professional liability insurance premiums, contributions to insurance and pension, or other deferred compensation plans, including but not limited to, Workers' Compensation and Social Security obligations, licensing fees, etc. and the filing of all necessary documents, forms, and returns pertinent to all of the foregoing.

Vendor shall hold harmless the State, and shall provide the State and Agency with a defense against any and all claims including, but not limited to, the foregoing payments, withholdings, contributions, taxes, Social Security taxes, and employer income tax returns.

- 36. INDEMNIFICATION: The Vendor agrees to indemnify, defend, and hold harmless the State and the Agency, their officers, and employees from and against: (1) Any claims or losses for services rendered by any subcontractor, person, or firm performing or supplying services, materials, or supplies in connection with the performance of the Contract; (2) Any claims or losses resulting to any person or entity injured or damaged by the Vendor, its officers, employees, or subcontractors by the publication, translation, reproduction, delivery, performance, use, or disposition of any data used under the Contract in a manner not authorized by the Contract, or by Federal or State statutes or regulations; and (3) Any failure of the Vendor, its officers, employees, or subcontractors to observe State and Federal laws including, but not limited to, labor and wage and hour laws.
- 37. NO DEBT CERTIFICATION: In accordance with West Virginia Code §§ 5A-3-10a and 5-22-1(i), the State is prohibited from awarding a contract to any bidder that owes a debt to the State or a political subdivision of the State. By submitting a bid, or entering into a contract with the State, Vendor is affirming that (1) for construction contracts, the Vendor is not in default on any monetary obligation owed to the state or a political subdivision of the state, and (2) for all other contracts, neither the Vendor nor any related party owe a debt as defined above, and neither the Vendor nor any related party are in employer default as defined in the statute cited above unless the debt or employer default is permitted under the statute.
- 38. CONFLICT OF INTEREST: Vendor, its officers or members or employees, shall not presently have or acquire an interest, direct or indirect, which would conflict with or compromise the performance of its obligations hereunder. Vendor shall periodically inquire of its officers, members and employees to ensure that a conflict of interest does not arise. Any conflict of interest discovered shall be promptly presented in detail to the Agency.

- 39. REPORTS: Vendor shall provide the Agency and/or the Purchasing Division with the following reports identified by a checked box below:

- **40. BACKGROUND CHECK:** In accordance with W. Va. Code § 15-2D-3, the State reserves the right to prohibit a service provider's employees from accessing sensitive or critical information or to be present at the Capitol complex based upon results addressed from a criminal background check. Service providers should contact the West Virginia Division of Protective Services by phone at (304) 558-9911 for more information.
- 41. PREFERENCE FOR USE OF DOMESTIC STEEL PRODUCTS: Except when authorized by the Director of the Purchasing Division pursuant to W. Va. Code § 5A-3-56, no contractor may use or supply steel products for a State Contract Project other than those steel products made in the United States. A contractor who uses steel products in violation of this section may be subject to civil penalties pursuant to W. Va. Code § 5A-3-56. As used in this section:
 - a. "State Contract Project" means any erection or construction of, or any addition to, alteration of or other improvement to any building or structure, including, but not limited to, roads or highways, or the installation of any heating or cooling or ventilating plants or other equipment, or the supply of and materials for such projects, pursuant to a contract with the State of West Virginia for which bids were solicited on or after June 6, 2001.
 - b. "Steel Products" means products rolled, formed, shaped, drawn, extruded, forged, cast, fabricated or otherwise similarly processed, or processed by a combination of two or more or such operations, from steel made by the open heath, basic oxygen, electric furnace, Bessemer or other steel making process.
 - c. The Purchasing Division Director may, in writing, authorize the use of foreign steel products if:
 - 1. The cost for each contract item used does not exceed one tenth of one percent (.1%) of the total contract cost or two thousand five hundred dollars (\$2,500.00), whichever is greater. For the purposes of this section, the cost is the value of the steel product as delivered to the project; or
 - 2. The Director of the Purchasing Division determines that specified steel materials are not produced in the United States in sufficient quantity or otherwise are not reasonably available to meet contract requirements.

42. PREFERENCE FOR USE OF DOMESTIC ALUMINUM, GLASS, AND STEEL: In Accordance with W. Va. Code § 5-19-1 et seq., and W. Va. CSR § 148-10-1 et seq., for every contract or subcontract, subject to the limitations contained herein, for the construction, reconstruction, alteration, repair, improvement or maintenance of public works or for the purchase of any item of machinery or equipment to be used at sites of public works, only domestic aluminum, glass or steel products shall be supplied unless the spending officer determines, in writing, after the receipt of offers or bids, (1) that the cost of domestic aluminum, glass or steel products is unreasonable or inconsistent with the public interest of the State of West Virginia, (2) that domestic aluminum, glass or steel products are not produced in sufficient quantities to meet the contract requirements, or (3) the available domestic aluminum, glass, or steel do not meet the contract specifications. This provision only applies to public works contracts awarded in an amount more than fifty thousand dollars (\$50,000) or public works contracts that require more than ten thousand pounds of steel products.

The cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than twenty percent (20%) of the bid or offered price for foreign made aluminum, glass, or steel products. If the domestic aluminum, glass or steel products to be supplied or produced in a "substantial labor surplus area", as defined by the United States Department of Labor, the cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than thirty percent (30%) of the bid or offered price for foreign made aluminum, glass, or steel products. This preference shall be applied to an item of machinery or equipment, as indicated above, when the item is a single unit of equipment or machinery manufactured primarily of aluminum, glass or steel, is part of a public works contract and has the sole purpose or of being a permanent part of a single public works project. This provision does not apply to equipment or machinery purchased by a spending unit for use by that spending unit and not as part of a single public works project.

All bids and offers including domestic aluminum, glass or steel products that exceed bid or offer prices including foreign aluminum, glass or steel products after application of the preferences provided in this provision may be reduced to a price equal to or lower than the lowest bid or offer price for foreign aluminum, glass or steel products plus the applicable preference. If the reduced bid or offer prices are made in writing and supersede the prior bid or offer prices, all bids or offers, including the reduced bid or offer prices, will be reevaluated in accordance with this rule.

43. INTERESTED PARTY SUPPLEMENTAL DISCLOSURE: W. Va. Code § 6D-1-2 requires that for contracts with an actual or estimated value of at least \$1 million, the Vendor must submit to the Agency a disclosure of interested parties prior to beginning work under this Contract. Additionally, the Vendor must submit a supplemental disclosure of interested parties reflecting any new or differing interested parties to the contract, which were not included in the original pre-work interested party disclosure, within 30 days following the completion or termination of the contract. A copy of that form is included with this solicitation or can be obtained from the WV Ethics Commission. This requirement does not apply to publicly traded companies listed on a national or international stock exchange. A more detailed definition of interested parties can be obtained from the form referenced above.

- **44. PROHIBITION AGAINST USED OR REFURBISHED:** Unless expressly permitted in the solicitation published by the State, Vendor must provide new, unused commodities, and is prohibited from supplying used or refurbished commodities, in fulfilling its responsibilities under this Contract.
- **45. VOID CONTRACT CLAUSES:** This Contract is subject to the provisions of West Virginia Code § 5A-3-62, which automatically voids certain contract clauses that violate State law.
- **46. ISRAEL BOYCOTT:** Bidder understands and agrees that, pursuant to W. Va. Code § 5A-3-63, it is prohibited from engaging in a boycott of Israel during the term of this contract.
