
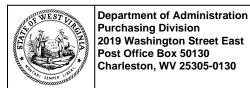

Commodity Line Comments: Our hourly rate for this project is \$200/hr. We estimate that we will spend 440 hours on this project.

We propose an intake meeting/call to review the project at the beginning. And periodic "check-in" calls to ensure our team and the client stay on the same page.
