- 2.4 “Solicitation”** means the official notice of an opportunity to supply the State with goods or services that is published by the Purchasing Division.

3. GENERAL REQUIREMENTS:

- 3.1 Contract Items and Mandatory Requirements:** Vendor shall provide Agency with the Contract Items listed below on an open-end and continuing basis. Contract Items must meet or exceed the mandatory requirements as shown below.

3.1.1 High Calcium Content Limestone Sand, delivered.

- 3.1.1.1** The Limestone Sand must have a Calcium Carbonate Content (not Calcium Carbonate Equivalent) greater than or equal to 90%. The vendor shall provide a copy of

- 3.1.1.2.3** 25% minimum passing a No. 20 Mesh Screen,
- 3.1.1.2.4** 30% maximum passing a No. 170 Mesh Screen.

3.1.2 The Acquisition and Utilization of all reasonable and necessary equipment, licenses, permits, specialized equipment, etc. will be the exclusive responsibility of the Vendor.

3.1.3 The Vendor shall deliver limestone sand in twenty to twenty-five ton truckloads. The quantity delivered shall be directed by the WVDEP AML representative.

3.1.4 The WVDEP/AML shall not be responsible for any terms of any subcontractor the primary Vendor may enter into to perform the duties of this contract.

4. CONTRACT AWARD:

4.1 Contract Award: The Contract is intended to provide Agencies with a purchase price on all Contract Items. The Contract shall be awarded to the Vendor that provides the Contract Items meeting the required specifications for the lowest overall total cost as shown on the Pricing Pages.

4.2 Pricing Pages: Vendor should complete the Pricing Pages by providing a price for every county listed above. The award of this solicitation may be split if it is in the best interest of the WVDEP/AML. If the Contract is awarded to the lowest bidder per County, on a price per ton delivered basis, vendors winning multiple Counties will have those Counties combined into a single contract. Vendor should complete the Pricing Pages in their entirety as failure to do so may result in Vendor's bids being disqualified.

5. ORDERING AND PAYMENT:

5.1 Ordering: Vendor shall accept orders through wvOASIS, regular mail, facsimile, e-mail, phone, or any other written form of communication. Vendor may, but is not required to, accept on-line orders through a secure internet ordering portal/website. If Vendor has the ability to accept on-line orders, it should include in its response a brief description of how Agencies may utilize the on-line ordering system. Vendor shall ensure that its on-line ordering system is properly secured prior to processing Agency orders on-line.

5.2 Invoicing: Vendor shall send invoices to depdlrprocurement@wv.gov upon completion of work.

5.3 Payment: Vendor shall accept payment in accordance with the payment procedures of the State of West Virginia.

5.3.1 Vendor shall be paid based on the unit price per line item (with units as listed). These prices must include all labor costs, mileage and travel costs, recycling costs and any other fees necessary to perform under this contract. No additional costs shall be paid.

6. DELIVERY AND RETURN:

6.1 Delivery Time: Vendor shall deliver standard orders within 72 hours of the order placed by a WVDEP/AML representative. The Vendor shall coordinate delivery with WVDEP/AML personnel, which shall be made Monday-Friday, 8am to 5pm EST. Saturday deliveries are only permitted with prior approval by WVDEP AML representative. Vendor shall deliver emergency orders within 2 (two) working day(s) after orders are received. Vendor shall ship all orders in accordance with the above schedule and shall not hold orders until a minimum delivery quantity is met.

6.4 Delivery Payment/Risk of Loss: Standard order delivery shall be F.O.B. destination to the Agency's location. Vendor shall include the cost of standard order delivery charges in its bid pricing/discount and is not permitted to charge the Agency separately for such delivery.

6.5 Return of Unacceptable Items: If the Agency deems the Contract Items to be unacceptable, the Contract Items shall be returned to Vendor at Vendor's expense and with no restocking charge. Vendor shall either make arrangements for the return within five (5) days of being notified that items are unacceptable or permit the Agency to arrange for the return and reimburse Agency for delivery expenses. If the original packaging cannot be utilized for the return, Vendor will supply the Agency with appropriate return packaging upon request. All returns of unacceptable items shall be F.O.B. the Agency's location. The returned product shall either be replaced, or the Agency shall receive a full credit or refund for the purchase price, at the Agency's discretion.

6.6 Return Due to Agency Error: Items ordered in error by the Agency will be returned for credit within 30 days of receipt, F.O.B. Vendor's location. Vendor shall not charge a restocking fee if returned products are in a resalable condition. Items shall be deemed to be in a resalable condition if they are unused and in the original packaging. Any restocking fee for items not in a resalable condition shall be the lower of the Vendor's customary restocking fee or 5% of the total invoiced value of the returned items.

7. VENDOR DEFAULT:

7.1.3 Failure to comply with any laws, rules, and ordinances applicable to the Contract Services provided under this Contract.

7.1.4 Failure to remedy deficient performance upon request.

8. MISCELLANEOUS:

8.1 No Substitutions: Vendor shall supply only Contract Items submitted in response to the Solicitation unless a contract modification is approved in accordance with the provisions contained in this Contract.

8.2 Vendor Supply: Vendor must carry sufficient inventory of the Contract Items being offered to fulfill its obligations under this Contract. By signing its bid, Vendor certifies that it can supply the Contract Items contained in its bid response.

8.3 Reports: Upon request from WVDEP/AML, the Vendor shall provide quarterly reports and annual summaries to the Agency showing the Agency's items purchased, quantities of items purchased, and total dollar value of the items purchased. Vendor shall also provide reports, upon request, showing the items purchased during the term of this Contract, the quantity purchased for each of those items, and the total value of purchases for each of those items. Failure to supply such reports may be grounds for cancellation of this Contract.

8.4 Contract Manager: During its performance of this Contract, Vendor must designate and maintain a primary contract manager responsible for overseeing Vendor's responsibilities under this Contract. The Contract manager must be available during normal business hours to address any customer service or other issues related to this Contract.
